On an authorisation of biocidal product Sinesto B through mutual recognition in Latvia

Latvian Environment, Geology and Meteorology Centre (LEGMC) has evaluated an application submitted by Wolman Wood and Fire Protection GmbH on 27th April 2018 concerning an authorisation of the biocidal product **Sinesto B** through mutual recognition in parallel.

LEGMC has agreed with Product Assessment Report and Summary of Product Characteristics for the biocidal product **Sinesto B** developed by the reference Member State – Germany.

Therefore, in accordance with Article 34 of Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products (regulation 528/2012) LEGMC authorises the biocidal product **Sinesto B** on the basis of mutual recognition process.

The biocidal product **Sinesto B** contains the following active substances:

- coco alkyltrimethyl-ammonium chloride (CAS No.: 61789-18-2; EC No.: 263-038-9), concentration 14% and
- disodium tetraborate, pentahydrate (CAS No.: 12179-04-3; EC No.: 215-540-4), concentration 3.97%.

LEGMC assigns the authorisation number LV/2023/MR/013 for the biocidal product Sinesto B.

The authorisation is valid until 8th December 2028.

The authorisation number shall be indicated on the label of the biocidal product.

The authorisation is granted on the following terms:

- Product type: 8 Wood preservatives;
- Target organism: wood discolouring fungi, blue-stain fungi and mould fungi;
- Users: industrial;

- Application methods: fully automated dipping and spraytunnel application;
- Product description: soluble concentrate;
- Product stability: 24 months.

The authorisation through mutual recognition applies only to the biocidal product **Sinesto B** in the composition, form and packing material for which the first authorisation is granted by reference Member State.

The information on the label (and if applicable an enclosed instruction of use) of the biocidal product **Sinesto B** should be as it is indicated in the first authorisation, taking into account also the information which is stated in the Product Assessment Report and Summary of Product Characteristics issued by reference Member State.

The information on the label shall be in Latvian.

Notwithstanding content of the label specified above, requirements stated in:

- Article 69 of regulation 528/2012,
- Regulation (EC) No. 1272/2008 of the European Parliament and of the Council of 16 December 2008 on classification, labelling and packaging of the substances and mixtures, amending and repealing Directives 67/548/EEC and 1999/45/EC, and amending Regulation (EC) No 1907/2006,
- all other relevant legislation shall be applied.

Wolman Wood and Fire Protection GmbH as the authorisation holder shall inform LEGMC about any changes in accordance with Commission Implementing Regulation (EU) No 354/2013 of 18th April 2013 on changes of biocidal products authorised in accordance with Regulation (EU) No 528/2012 of the European Parliament and of the Council.

If the first authorisation issued by reference Member State is amended or revoked, the authorisation of biocidal product **Sinesto B** through mutual recognition may be reopened for review before the 8th December 2028.

Additionally, LEGMC would like to inform that Wolman Wood and Fire Protection GmbH is fully responsible of the content of the biocidal product **Sinesto B** as well as its classification, labelling, instruction of use and safety data sheet.

LEGMC would like to ask Wolman Wood and Fire Protection GmbH to notify the above mentioned information down to supply chain.
