Declarations of the members and alternates of the Board of Appeal

(Decision by the Management Board)

Summary

As the appointing authority of the members and alternates of the Board of Appeal, within the meaning of Article 89(3) of the REACH Regulation, the Management Board is invited to adopt the models for the declaration of commitment and confidentiality and the declaration of interests that a member of the Board of Appeal, its additional members and/or an alternate will be asked to make upon taking up his/her duties on the Board of Appeal.

1. Introduction

Pursuant to the applicable rules of procedure, members of the Management Board, of ECHA's Committees and Forum are obliged to make a declaration of commitment to fulfil their duties and a declaration of interests. The same obligation applies also to the staff of the Agency on the basis of the Executive Director's decision¹ prescribing a declaration of commitment and confidentiality, a declaration of interests and guidance on conflict on interests and on invitations and gifts.

Considering that the 'permanent' members of the Board of Appeal are appointed as members of temporary staff within the meaning of Conditions of Employment of Other Servants of the European Union, ECHA's Code of good administrative behaviour and the above Executive Director's decision, should also in principle apply to the members.

However, taking into account that it is the Management Board who, in its role of the appointing authority, appoints the Board of Appeal, the above-mentioned decision does not apply to the members and alternates of the Board of Appeal. Consequently the Management Board is called upon to adopt similar declarations in respect of members and alternates of the Board of Appeal.

The purpose of the present note is to propose that the Management Board adopt the declaration of commitment and confidentiality and the declaration of the interests applicable to the members of the Board of Appeal. Even though alternates and additional members of the Board of Appeal are not staff of the Agency within the meaning of Article 103(3) of Regulation (EC) No 1907/2006² (hereinafter the "REACH Regulation"), the obligation to make a written declaration of commitment and confidentiality and to produce the annual declaration of interests should also apply to these 'non-permanent members' of the Board of Appeal.

2. Legal basis

The general obligation for the staff of the Agency to complete, upon taking up their posts, the declaration of commitment and confidentiality and declaration of interests, as outlined in the

decision of the Executive Director, stems from the provisions of Article 88(2) and 105 of the REACH Regulation.³

The necessity for the members of the Board of Appeal to submit themselves to the obligation of signing the declarations is further warranted by the provision of Article 90(2) of the REACH Regulation, providing that the members of the Board of Appeal shall be independent and shall not be bound by any instructions in making their decisions. Furthermore, according to Article 90(5) of Regulation (EC) No 1907/2006, members of the Board of Appeal may not take part in any appeal proceedings if they have any personal interest therein, or if they have previously been involved as representatives of one of the parties to the proceedings, or if they participated in the decision under appeal.

With regard to confidentiality, the Commission Regulation governing the appeal procedure before the Board of Appeal⁴ also provides that its deliberations shall be and shall remain secret. As the tasks and responsibilities of non-permanent members, who represent the members of the Board of Appeal in their absence, are in principle identical, the abovementioned provisions of Article 90 also apply to non-permanent members.

In addition, these requirements were also evoked in the call for expression of interest in the appointment as members of the Board of Appeal or their alternates or additional members and their alternates⁵ which stated that the members and their alternates will be required to declare any interests, which may conflict with their duty to the Board of Appeal, in compliance with Article 90(5) and (6) of Regulation (EC) No 1907/2006.

With regard to all of the above, it is proposed that the Management Board in its role of the appointing authority of the Board of Appeal members and alternates, within the meaning of Article 89(3) of the REACH Regulation, requests the members and alternates of the Board of Appeal to make a declaration of commitment and confidentiality and to produce an annual declaration of interests.

3. Declarations

With regard to the **declaration of commitment and confidentiality**, it is proposed that the members of the Board of Appeal and their alternates complete and sign a form resembling the one that had been previously approved by the Management Board for the members of the Committees and of the Forum, modified to better reflect the tasks of a member or of an alternate of the Board of Appeal. The models of the declaration of commitment and confidentiality are contained in Annex 1 and Annex 2.

The text of the declaration intended for alternates and additional members of the Board of Appeal differs slightly from the one intended for permanent members, in order to take into

account the characteristics linked to the 'ad hoc' nature of the positions of non-permanent members, as their permanent presence in Helsinki will not be required. When an alternate or additional member is asked to participate in an appeal procedure, the Registry of the Board of Appeal will send the related procedural documents to the address designated by him for that purposes. In order to take note of that, the fifth paragraph of the declaration applicable to alternates and additional members evokes the responsibility of non-permanent members for the proper handling of the documents, related to a given appeal case, while they are in their possession.

Regarding the **annual declaration of interests**, it is proposed that the Management Board adopt the form similar to that used for the staff of the Agency, pursuant to which financial interests in a company relevant to the operating area of ECHA exceeding 10 000 euros have to be reported.

It has to be however noted that, in the case of members of the Committees and of the Forum, the Management Board set that threshold at the amount of 50 000 euros. Nevertheless, in order to underline the importance of having the independent Board of Appeal, it is proposed that the stricter threshold of 10 000 euros be applied to members of the Board of Appeal and their alternates. The model of the declaration of interests is attached to this note as annex 3.

By analogy to Article 88(2) of the REACH Regulation, it is proposed that these declarations be kept in the Registry of the Board of Appeal and be accessible to the public, on request at the Registrar's offices. The Registrar should also see that the members of the Board of Appeal and their alternates make declaration of interests on an annual basis.

4. Action requested

The Management Board is invited to:

- decide that the members and alternates of the Board of Appeal be requested to make a declaration of commitment and confidentiality and an annual declaration of interests in accordance with the models contained in Annexes 1 to 3;
- give the Registrar of the Board of Appeal the mandate to administer the practical actions related to the gathering of the declarations and their keeping.
