Opinion development process in a nutshell:
Submission of AfA in the window + 2 to 2.5 months for checks, broad information on uses and payment = start of public consultation (PC)
Start of PC = start of Working procedure, first SEAC meeting 16(-17) weeks (4 months), second SEAC meeting 29(-30) weeks (7 months)
