I. Summary record of the proceedings

Item 1 - Welcome and introduction

1.1 Opening by the Vice-Chair of the Forum

The Chair welcomed all the participants. She announced apologies from Liechtenstein and Slovenia. She announced that Croatia was nominated as the proxy for Slovenia.

The Chair informed that the quorum requirement was met.

1.2 Adoption of the agenda

The Chair indicated the changes in the agenda (Content IV, <u>Annex 1</u>). The agenda was adopted.

1.3 Declarations of conflicts of interest with regard to agenda items

The Chair requested all participants to declare any potential conflicts of interest for any of the agenda items, according to Article 9(2) of the Rules of Procedure. No conflicts of interest were declared in the meeting.

1.4 State of play with action points from Forum-30

The ECHA Forum Secretariat informed the plenary on the status of the action points from Forum-30 and highlighted the open actions.

1.5 Report of the written procedures and other issues between Forum-30 and Forum-31

The Chair referred to the document with the results of the written procedures between Forum-30 and Forum-31.

A Forum member raised the issue that various consultations of the different projects generate various deadlines and suggested for it to be streamlined.

Item 2- Preparation for the open session

The Forum discussed and agreed on the common approach concerning the topics for discussion in the open session.

Item 3- Welcome and Introduction to the open session

3.1 Welcome to the Stakeholders

The Chair welcomed the 17 ECHA Accredited Stakeholders (ASOs) participating in the meeting. This was the first time the open session was prepared jointly with the Forum Biocidal Products Regulation Subgroup (BRPS). She welcomed the five observers representing the Instrument for Pre-Accession Assistance (IPA) programme.

3.2 Introduction of the Forum BPR Subgroup

The BPRS Chair presented the BPRS' mandate and the work done since this body that was set up in Forum 1,5 year ago, to deal with the enforcement of the Biocidal Products Regulation.

Item 4 - Opening address by ECHA

The ECHA's Head of Unit of the Support, Forum and HelpNet Secretariat Unit welcomed the participants and highlighted some topics to be discussed during the day.

Item 5 - Joint initiative ECHA Forum - ECHA ASOs on Improvement of the quality of SDSs

5.1 Discussion with the ASOs on opportunities for improvement of the quality of SDS

5.1.1 WG provisional findings

The WG chair presented a summary of the activities of the WG that was set-up to try to help improve the quality of the safety data sheets (SDSs) in collaboration with the stakeholders. At the time, approx. 200 SDSs were gathered from 12 participating countries. The WG prepared the methodology for the analysis of the data, aiming at profiling the common deficiencies for different sections of the SDS. He presented the findings so far on the missing or not adequate/appropriate information in the different sections. The WG would then propose solutions for improvement and encouraged ECHA ASOs to implement the solutions and monitor the progress.

5.1.2 Member State experience

A Forum member shared that in his country, they have identified a large number of problems with the distribution and quality of SDSs. They have implemented programmes, prepared guides and developed tools in close cooperation with industry to address these shortcomings. He proposed some ideas to improve the quality of SDS that the WG will discuss.

A stakeholder suggested considering the project on digitalisation of SDS also in the context of Poison Centres, as similar information would need to be provided, ideally, using the same software/data base. The same tool could be used, to some extent, to combine information about what was supplied with the SDS.

5.1.3 Stakeholder experience

The CEFIC representative briefed the meeting on their work in the Exchange Network on Exposure Scenarios (ENES), whose work Programme has identified 24 actions supporting the supply chain communication. He presented the ENES tools already in place for down and up-stream communication and identified the areas that could use further cooperation between all actors to better define and describe the content and application of extended SDS.

5.1.4 Discussion on possible solutions and next steps

The WG would continue to analyse the SDSs submitted and would discuss the findings and actions to improve SDS with the ASOs. The list of improvement actions would be presented in the 2019 open session (November 2019, Forum-34). The WG would then be closed and the follow-up on the implementation of the actions would be reported by the ASOs in future open sessions.

The ASOs were invited to submit initiatives taken to improve the quality of SDSs as well as to join the WG.

5.2 WG Mandate amendment

Some ASOs expressed their interest in participating in the WG and were added to the mandate. The timeline was adjusted according to the proposed actions. The Forum adopted the revised mandate of the WG (Annex 2p).

Item 6 - Discussion topics proposed by ASOs

6.1 European Association of Chemical Distributors (Fecc)

6.1.1 Management of ES information in SDS - Distributors' consolidation methodology

The presenter shared with the Forum their guidance "Distributors' consolidation process" on management of exposure scenario (ES) information in SDS. It was developed by distributors to make the supply chain communication more efficient in the context of the ENES 2020 Programme to standardise the best practices. Additionally, some pilot projects were running to better assess the methodology.

Some participants requested clarification on some issues from the presentation. The Chair informed on the REF-5 project, under finalisation, about the communication of exposure scenarios in the supply chain. The findings were in line with the concern of Fecc, on the low quality of the safe use information from the chemical safety report (CSRs) passed in the supply chain. However, the mechanism for transferring the ES information along the supply chain was seen to be working effectively. The REF-5 project was prepared in alignment with the current ENES programme and the report included some recommendations taking into account the actions mentioned in the ENES programme. Moreover, the Forum mandated three Forum representatives to follow the discussion in ENES.

The Forum took note of the presented guide but explained it does not endorse industry-made guidance. However, the Forum/BPRS members interested to comment individually on the Fecc's documents were invited to do so.

6.1.2 Fecc good practice guidance: Storage tank management for Active Substances under BPR

The presenter shared with the Forum their document on "Good practice guidance on Storage tank management for Active Substances under BPR" prepared by the organisation's Biocide task force.

Some participants asked for clarification on some of the issues presented. The BPRS appreciated the effort to trace the process and took note of the guidance presented. However, the BPRS explained it does not endorse industry-made guidance but the members were invited to comment individually on the organisation's guidance and future versions.

6.2 Aerospace and Defence Industries of Europe (ASD)

Enforcement issues at manufacturers of articles' whilst no EU IT Infrastructure is in place for codification and distribution of SDSs

The presenter brought to the Forum the challenges the manufacturers of articles face, in particular related to poor information in the SDS. They were in the endpart of very complex supply chains and often received non-compliant SDSs from their suppliers. In order to fulfil their obligations, manufacturers of articles had to create their own database linking the chemical products (mixtures) to their substance. As no unique identifier was presently available for mixtures, the reliability of such internal databases was low.

The Forum acknowledged the challenges and suggested for the article manufacturer to put pressure on their suppliers, or even find another supplier, in case they received non-compliant SDSs and to inform the NEA of the country of the non-compliant supplier. Moreover, the 'declaration of compliance' that some suppliers provide to their customers would need to include the relevant information.

The ECHA Forum Secretariat added that Annex VIII of CLP the mixture information notified to appointed bodies will be available only to these appointed bodies for the purposes of medical demands in emergency and for statistical purposes and possibly to enforcement authorities. ECHA was currently working on the Poison Centres Notification (PCN), which the first version was planned for Q1 2019 and a second version for November 2019.

The COM representative highlighted that the same issue was identified in other industry sectors and recommended cooperation between them.

A Forum alternate gave some examples of the recommendations given by inspector to companies in her country.

6.3 European Consensus Platform for 3R Alternatives to Animal Experimentation (ECOPA)

Regulatory Acceptance of Read-Across approach

The presenter highlighted the Read Across as the most used alternative technique to waive new *in vivo* animal tests. Even though well described in Annex XI of REACH and Annex IV of BPR, the initial Read Across justification in registration dossiers often lack strong scientific justification. This has triggered initiatives to improve the robustness of the approach and the scientific endorsement for better regulatory acceptance. As inspectors have direct contact with the companies, they can have a role as multipliers of this information for it to reach the right audiences.

The Forum took note of the use of Read Across for the fulfilment of information requirements. However, the NEAs only deal with such situations in the follow-up to dossier evaluation decisions and rely on the assessment of ECHA and the Competent Authorities. The Chair informed about the Forum's activities on the REACH provisions related to reduction of unnecessary animal testing, in particular regarding tests with no testing proposals and cases related to the potential breach of the requirement to use animal testing as last resort under Article 13(1).

6.4 International Association for Soaps, Detergents and Maintenance Products (A.I.S.E.)

6.4.1 Learnings from the 2016 Forum pilot project on child-resistant fastenings and AISE safe use campaign

The presenter informed on the actions triggered by the Forum Pilot project on child-resistant fastenings, where inspectors found a relatively high non-compliance rate (29%) with Article 35(2) of CLP. The Forum recommended improving the companies' knowledge on the importance of the mentioned requirement and that it was essential for guidance and support to be provided by stakeholder organisations, particularly for SMEs. Therefore, the organisation would issue a short and simple guidance aiming at SMEs, involving retailers and distributers. When available, the Forum members were invited to comment individually on the guidance.

Some Forum members mentioned some experiences with the enforcement of child-resistant fastenings and that some problems derived from wrong classification. The Chair noted that awareness on the issue should also be raised at the top of the supply chain, among the formulators, re-fillers or importers of hazardous products.

The presenter informed on the campaign launched in different countries, with different partners, with the view to raise awareness and educate parents on the safe use of this product type. The Forum members were invited to express interest in becoming a partner of such campaign.

A Forum member shared the results of a national project that collected data from the hospitals on accidental poisonings of children with liquid laundry detergent capsules. Forum members raised concern on the fact that the number of such accidents have been raising in the last years, with the continued raise of market share of such products. Moreover, there should be campaigns also to raise awareness on the compliance with CLP regulation on the packaging provisions.

6.4.2 Bridging principles and mixture classification under CLP and DetNet: challenges and opportunities

The presenter updated the Forum on DetNet, an IT tool developed by the organisation to help their members to classify their mixtures under CLP.

The Forum noted the continued development of the tool and the challenges reported by the detergent industry to comply with the stringent rules set in the CLP Regulation.

The Chair responded saying that Forum may not give a blanket approval for any classifications proposed in DetNet. The calculation method is one of the legitimate and legally binding methods of applying the CLP classification, so enforcement authorities have full legal basis to refer to it in their judgements regarding classification. Ultimately, correctness of classification (and resulting label) for a specific mixture is conducted on a case-by-case basis. If found that the use of bridging principles in DetNet was not correct and according to CLP, the inspectors would request the company to change the classification from DetNet. Individual Forum Members were invited to contact the organisation to get access to the tool.

Some Forum members and invited experts shared their experiences when inspecting companies that used the tool.

6.4.3 Labelling of treated articles under BPR: case of detergents

In light of the first enforcement project of the BPRS focused on treated articles (BEF-1), the presenter gave examples of specific cases of detergents and cleaning products, especially with regard to the labelling elements, since there were some common elements in the labelling requirements in BPR and the Detergent Regulation.

The BPRS took note on the examples presented. In case of dual/triple labelling requirements, the BPRS inspectors undertaking the BEF-1 project will focus on checking the BPR labelling requirements for treated articles defined under Article 58(3) and 58(6) of BPR as well as any additional national requirements for the treated article labels.

Replying to a BPRS member, the presenter informed that, whenever there was an approval decision for the relevant active substances, this information was disseminated via their network of national associations for them to convey the message to SMEs, as much as possible. Additionally, in the public list of harmonised classification approved by RAC, there was an indication if it was a biocidal product, or used in plant protection products, etc., ECHA could make this information more visible.

6.5 European Apparel and Textile Confederation (EURATEX)

Urgent need for better market surveillance for textile and apparel products

The presenter highlighted the importance of having a level playing field between EU and non-EU companies, as the EU-based textile industry has to put extra efforts

to comply with REACH, namely concerning the restrictions. The new restrictions would cover a group of chemicals and the question raised was how the market surveillance authorities will deal with it, especially in terms of testing and market surveillance.

The Chair informed that restrictions were one of the priority areas for the Forum (REF-4, pilot on substances in article, REF-8). Results of REF-4 indicated that there was low level of non-compliance for restrictions relevant for the textile industry. Other Forum members shared their national campaigns on restrictions. One strategy that could be used to tackle the group of chemicals covered by the future restrictions could be to identify the top importers and check if they have practices in place to ensure that their imports are compliant.

The organisation was invited to propose a topic for a future Forum project and to indicate specific restriction entries that could be checked already by customs in the upcoming pilot project with customs. Such list of restriction could be shared with the national coordinators for them to consider controlling these restrictions during the operational phase of the pilot project.

6.6 European Chemical Industry Council (CEFIC)

6.6.1 Improved collaboration between enforcement authorities and stakeholders

The presenter suggested for the stakeholders to cooperate more with the NEAs by approaching the NEAs with concrete evidence of non-compliance by other company, so that it could trigger direct enforcement actions towards that company. Examples of such non-compliance could be in respect to registration, not sharing costs after receiving the registration number and in regard to the use of substances subject to authorisation and restricted. Industry was ready to cooperate with NEAs. They were interested to know the type of evidences needed by inspectors and what could be the process for such communication.

The Forum welcomed the suggestion and informed that follow-up of complaints about suspected breach of duties were already a practice in many Member States. In case there was a suspicion of a breach of duty, the inspectors welcomed all information available to support that suspicion. The NEA where the non-compliant company was based is the correct authority to contact. NEA's contact information for all EU countries is available in ECHA's website. Moreover, companies were invited to submit information on legacy substances that were used in articles to ECHA so that it can be shared with NEAs.

Some Forum members shared their procedures to follow-up complaints and such investigations could be initiated by a simple contact with the authorities. However, the complaint should be supported with as much evidences as possible for the inspectors to investigate.

6.6.2 REACH Exposure Scenario Compliance Check: Industry experience and a proposal for a pragmatic approach

The presenter shared their proposal for a pragmatic approach for enforcing exposure scenarios, as the information in the CSRs are often of poor quality and the risk management measures are difficult to implement in the workplace. She gave a few examples of mismatching information provided by different suppliers, illustrating the challenges of the users to comply with article 37 of REACH while, at the same time, not contributing to a higher level of safety. She proposed for inspectors to check the use coverage but limit the checks on RMM and OC, as long as safe use according to OSH legislation was demonstrated.

The Forum acknowledged the difficulties faced by the companies but did not support the simplified approach presented, as the companies have to fulfil their REACH duties. The Chair informed that the Forum was addressing the interface between OSH and REACH during inspections and COM was preparing a document on the issue.

The participants shared that the fundamental problem was the low quality of the information in exposure scenarios/CSR and that this should be the main issue to be tackled.

Item 7 – SLIC-CHEMEX Working group 7.1 REACH implementation in the work place

The SLIC representative informed the meeting on the scope of the work of the senior labour inspectors and the overlapping with REACH and highlighted the SLIC Guidance published for national labour inspectorates on 'enforcement and interaction of REACH/CAD and CMD'. He shared the observations from the labour inspectors concerning exposure scenarios, which were not used or trusted as work place risk assessment. Even though the difficulties faced by the downstream users regarding their obligations were noted, the REACH text was flexible enough for them to comply. However, more work was required to improve the usability of SDS and ES and more trust was needed in the quantitative models and limit values, in order for REACH generated information to be perceived as added value and not as a burden.

Replying to participants, the labour inspectors observed that the Downstream Users (DU) lack information to perform appropriate scaling. What was found instead was the workplace risk assessment was compiled using quantitative models or other methods. If the assessment shows safe use, the labour inspectors accepts it. The investigations of the actors up in the supply chain were also done by labour inspections and the collaboration between REACH and labour inspectors were very dependent of the national organisation.

Item 8 – Updates from the Forum/BPRS 8.1 Update on the scope of REF projects

The chair of the Forum WG 'Prioritisation of REF projects' presented the results of the prioritisation exercise of 2018, where the new project REF-8 was selected and focuses on 'on-line sales including restrictions'. The prioritisation exercise also recommended undertaking an awareness raising campaign on mixtures with extreme pH. The stakeholders were invited to submit new or re-submit old project proposals for assessment in the 2019 prioritisation cycle, for which the deadline for submissions is 19 April 2019. If not taken individually, the proposal could be complemented by others to define the scope of the next REF project.

8.2 Forum's finalised projects during 2018

The Forum Vice-chair summarised the results of the three projects finalised during 2018, namely the project <u>REF-5</u>, and the pilot projects on the control of <u>internet</u> sales and <u>control of PIC</u>.

COM representative communicated that COM was contacting online platforms to implement actions to avoid selling non-compliant products online. Thus, it was expected for REF-8 project to find less non-compliances than the pilot project on the same subject.

A.I.S.E. informed that online sales was already under the radar of the organisation and they had discussions planned on the digitalisation of information as a way to improve the distribution of safe use information.

8.3 Cooperation with customs - upcoming pilot project

The chair of the WG 'Cooperation with customs 2' reminded of the previous activities where the Forum cooperated with customs. A new pilot project will run in 2019 focusing on the investigation of three restrictions entries (23, 27, 63) and CLP labelling. For the purpose of the pilot project, several models of cooperation were identified, depending on whether REACH/CLP compliance affected the release by Customs for free circulation or not.

Item 9 - Conclusions and actions points from the open session

The participants agreed on the action points for the meeting.

The Chair thanked all participants and closed the open session.

Item 11 - Welcome from COM DG GROW

The Head of Unit of the REACH Unit of DG GROW welcomed the Forum to Brussels and congratulated the work of the Forum.

Item 12 – Debriefing of the Open Session and Enforcement Conference

The Forum appreciated the high number of stakeholders and the various issues brought forward. Moreover, stakeholders shared the actions they have put in place to address their own challenges. The BPRS Chair welcomed the fact that it was joint session and found it successful.

Item 13 - Forum's enforcement activities- Projects under preparation

13.1 REF-8

13.1.1 Mandate set-up

The Chair of BPRS informed the preference of the BPRS members in participating in the Forum's project, with the aim of having information about the classification and labelling elements for biocidal products sold online.

The Forum agreed to have BPR elements in the scope of the REF-8 project "Enforcement of CLP, REACH and BPR duties related to substances, mixtures and articles sold on-line". The Forum adopted the mandate of the WG (Annex 2a).

Item 14 - Forum's enforcement activities- Ongoing projects

14.1 Forum Action Programme 2019-2023

14.1.1 WG progress report

The WG chair informed that the Forum Multiannual Work Programme (MAWP) 2019-2023 was finalised, taking into account the comments submitted by the Forum members and ECHA management during the two consultation rounds. The BPRS was consulted during their plenary (BPRS-6) and agreed with the proposed MAWP.

14.1.2 Adoption of the Forum's MAWP 2019-2023

The Forum adopted the Forum's work programme for the next five years.

14.1.3 Survey on OSH and REACH enforcement

The WG chair informed that task 6 of the WG mandate concerning the OSH-REACH survey was still open and for that requested the Forum to nominate additional OSH experts. The WG suggested creating a new WG focusing only on the preparation of the survey on existing interactions in enforcement of OSH and REACH.

14.1.4 Mandate amendment

The WG 'Forum Action Programme 2019-2023' was closed and a new WG "OSH REACH Survey" was created to take forward the preparation and conduct of the OSH-REACH survey. The Forum adopted the new mandate (Annex 2b).

14.2 Prioritisation of REF projects

14.2.1 WG progress report

The WG chair briefed the Forum on the activities of the WG. She informed the REF methodology was updated to include the terminology to be used also by the BPRS to cover the Biocides Enforcement Projects (BEF). Other changes to reflect the timings of the BEF projects were also included. This new version of the methodology was adopted by the BPRS. The Forum adopted the 'Methodology for the selection, management and evaluation of harmonised enforcement projects, coordinated by the Forum and the BPRS' (REF and BEF project methodology).

13 Forum members indicated their interest in participating in the pilot project on recovered substances. The Forum agreed to initiate the operational phase of the pilot project on 2020.

14.2.2 Mandate amendment

A new chair for this WG was appointed. The Forum adopted the revised mandate of the WG (Annex 2c).

14.3 Third pilot project on authorisation

14.3.1 WG progress report

The Chair summarised the work of the WG, which implemented the comments received from the Forum members on the draft project manual.

14.3.2 Mandate amendment

SLIC-CHEMEX would discuss with the network the possible involvement of a representative in this WG. The Forum adopted the updated mandate (Annex 2d).

14.4 REACH-EN-FORCE-6 on CLP

14.4.1 WG progress report

The Chair informed that the operational phase of this project was ongoing.

14.4.2 Enforcement of Article 45 and Annex VIII of CLP

The WG was mandated to define the scope of the enforcement activities under Article 45 and Annex VIII of CLP *i.e.* obligation for industry to submit information on hazardous mixtures placed on the market. The Forum discussed the issues highlighted by the WG and what would be required to guarantee proper enforcement.

14.4.3 Enforcement of liquid laundry detergent capsules (LLDC) in REF-6

The German expert presented the experiences when checking the LLDC during the operational phase of the REF-6 project.

14.4.4 Mandate amendment

The Forum adopted the updated mandate (Annex 2e).

14.5 Implementation of PD-NEA

14.5.1 WG progress report

The Chair informed that the WG tested the new functionalities and evaluated that the data and functional requirements were implemented.

14.5.2Update on ECHA IT tools for inspectors

ECHA Forum Secretariat informed on the updates that came with the new release of the PD-NEA tool as well as the upcoming changes.

14.5.3 Mandate amendment

The Forum adopted the updated mandate (Annex 2f).

14.6 REACH-EN-FORCE-7 on Registration

14.6.1 WG progress report

The WG chair informed that the project manual was adopted. All 31 Member States nominated National Coordinators that have received the needed training.

14.6.2 Mandate amendment

The Forum adopted the updated mandate (Annex 2g).

14.7 Training for enforcement trainers 2019

14.7.1 WG progress report

The Forum took note of the progress report submitted for the meeting.

14.7.2 Discussion of the proposed topics

The WG chair informed on the topics proposed by the Forum members for the training event of 2019 (2-3 October 2019). The Forum discussed and agreed on the main topic for next year's training to be the issues under the scope of REF-8, control of internet sales. The Forum members and COM were invited to submit any available materials concerning the issue.

14.7.2 Mandate amendment

As it was discussed under the <u>REF-8 item</u>, the BPRS would be participating in the project and would have interest in participating in the training as well. Therefore, the training event would be organised for trainees appointed by both Forum and BPRS members. Since the number of participants would be higher than normal, a request was launched for the nomination of additional WG members (trainers).

The Forum took note that BPRS was organising a 'Training for enforcement trainers 2019' event concerning BPR issues only.

The Forum adopted the updated mandate (Annex 2h).

14.8 Categorisation of risks

14.8.1 TF progress report

The ECHA Forum Secretariat informed about the progress of the work of the Task Force (TF) that collected feedback from the Forum members after Forum-29 regarding the notifications to RAPEX.

14.8.2 Mandate amendment

A chair was appointed, hence the TF changed into a WG. The Forum adopted the revised mandate of the WG, including a revision of the tasks and an extension of the timeline (Annex 2i).

14.9 Pilot project on Substances in Articles (SiA)

14.9.1 WG progress report

The Chair summarised the activities of the WG and on the state of play of the national inspections. The operational phase will continue until 31 December 2018.

14.9.2 Mandate amendment

The Forum adopted the updated mandate (Annex 2j).

14.10 Cooperation with Customs 2

14.10.1 WG progress report

The WG chair informed that the manual for the pilot project, after being consulted with Forum members, was also consulted with the national coordinators and was finalised and ready for adoption. 15 Member States would participate in the pilot project.

14.10.2 Adoption of pilot project manual

Some Forum members requested to extend the timeline of the operational phase until the end of 2019 to better align with their annual planning. In order to take into account some last-minute comments, the Forum agreed to have one more - final - consultation round and adopt the manual via written procedure after the meeting. That implied that the start of the operational phase was shifted to March 2019.

14.10.3 Mandate amendment

Taking into account the request of the Forum members, the timeline of the project was adjusted and the Forum adopted the updated mandate (Annex 2k).

14.11 Enforceability of restrictions

14.11.1 WG progress report

The WG chair informed about the activities of the WG concerning the advices elaborated after Forum-30 and the number of future Annex XV proposals. An increase in the number of proposals to be processed (12 dossiers in 2019) was noted, which was causing difficulties in finding resources within the WG. The WG chair highlighted the new dossiers that would still require rapporteurs and invited the Forum members to volunteer or to appoint experts. Ideally, the rapporteurs should also be a WG member but in light of the lack of resources, Forum members/experts could be appointed as rapporteurs on an *ad-hoc* basis.

The WG started to prepare the second edition of the Forum Compendium of analytical methods. So far, no input from Stakeholders was received but the WG would consult various actors during 2019 to collect further feedback.

Additionally, the WG elaborated a first draft of the Registry of Concerns and elaborated templates to assess the enforceability of newly adopted Annex XVII restrictions and the list of new Annex XVII restrictions.

With the view to use the scarce resources of the WG in a more efficient way during 2019, the WG proposed to prioritise its work to focus in their main mandated task, providing advice on the enforceability of restrictions, and postpone all the other activities for 2020.

14.11.2 Mandate amendment

The Forum agreed with the proposal to prioritise the work of the WG and adopted the updated mandate, including the changes in the timeline of the abovementioned tasks for 2020 (Annex 21).

Item 15 - Practical issues for enforcement of REACH and CLP

The ECHA Forum Secretariat informed that there were two practical issues running in the fast-procedure in HelpEx.

Issue 21.2 - Who is responsible for the elaboration of a Safety Data Sheet when an only representative is appointed?

ECHA Forum Secretariat reminded that the Forum was consulted on this issue after Forum-30. There were requests to describe new scenarios in the practical issue, hence COM will be requested to provide further clarification. Once received, the issue will be discussed in the Forum for conclusion.

Issue 26.4 - Can NEAs accept test results on a multi-constituent substance containing a constituent with a harmonised classification in Annex VI where the test result contradicts the classification of the multi-constituent substance based on its constituents?

ECHA Forum Secretariat informed that the HelpEx consultation on the issue was not conclusive. The draft conclusion was revised and re-discussed at the HelpNet Steering Group in October, where it was agreed. A revised version was posted in HelpEx for the final consultation. The ECHA Forum Secretariat will now draft a conclusion for this issue to reflect the agreed solutions and initiate a written consultation with the Forum.

Issue 29.4 - Is it possible for the applicant and DUs to implement different conditions than what appears in the CSR?

The issue concerned the situation where OC/RMM found on the site differed from the ones in the CSR and from the application and authorisation. The ECHA Forum Secretariat informed that the issue has been suspended until further feedback has been received from COM.

Issue 31.1- Does the registration obligation apply to substances in fireworks?

The submitter of the issue presented the case encountered where companies state that they import articles and therefore do not need to register any substances in

the fireworks. The Forum discussed this issue and would continue the discussion via written consultation.

Issue 31.2- Can resellers and other intermediate traders be part of a supply chain of creosote treated wood?

The submitter presented the case based on the text of entry 31 of REACH Annex XVII, which covers the placing on the market of wood treated with creosote. The Forum Secretariat prepared a draft conclusion based on the available Q&A 1067, which explained the applicability of the phrase "placing on the market for the first time". The issue would be further consulted with the Forum and the draft conclusion would be revised.

Item 17 – Forum's enforcement activities- projects under finalisation

17.1 REACH-EN-FORCE-5 on Extended SDS, exposure scenarios, risk management measures and operational conditions

17.1.1 WG progress report

The Chair informed that the WG have drafted the project report, taking into account the Forum members comments. The report was under adoption during the Forum-31 meeting and the Forum members were invited to reply to the written procedure. The WG also started drafting the 'Tips and hints' document, which will be consulted with the national coordinators and finalised in the beginning of 2019.

17.1.2 Discussion on the follow-up of the project results

In the open session, under item 8.2, the Forum Vice-Chair presented the results of the REF-5 and recommendations to Industry. A WG member, in the absence of the WG chair, presented the conclusions and recommendations from the project and proposed some follow-up actions to address them.

COM representative welcomed the recommendations for COM and noted that some of the actions were being addressed under the REACH review.

Some Forum members shared that the project was very useful and that the results support that the control of extended SDS/CSR should continue to be a priority in the Member States.

Forum members questioned whether the exercise done by ECHA Secretariat under the scope of the REF-5 project, checking in detail the content of the some CSRs could be continued and requested in an *ad-hoc* basis and even extrapolated for the Evaluation process. ECHA Forum Secretariat informed that it would need advance planning, as these tasks were very resource intensive.

The WG had not discussed on submitting a project proposal for the next prioritisation cycle of REF projects on the topics of REF-5. This action would be for the Forum members, in case of interest.

17.1.3 Mandate amendment/closure

The timeline for the completion of the "Tips and Hints" was amended and the Forum adopted the updated mandate. The Forum conditionally closed the mandate of the WG, as all the deliverables were expected before the next plenary meeting (Annex 2m).

17.2 PIC pilot project

17.2.1 WG progress report

The Chair summarised the activities of the WG. The draft report was prepared and was under consultation with the Forum. It was foreseen that the written procedure for the adoption would be launched in early December, followed by the publication of the report still in 2018. The WG would prepare the "Tips and Hints" document in the beginning of 2019.

17.2.2 Discussion on the follow-up of the project results

In the open session, under item 8.2, the Forum Vice-Chair presented the results of the PIC pilot project and recommendations to Industry. The WG chair presented the draft conclusions and recommendations from the project to the other actors in the project and made some proposals for actions to address the recommendations.

A COM representative welcomed the finding concerning the need to improve the unique code system used by Customs authorities. Some Forum members confirmed that the CN codes were very broad for some chemicals making it difficult target the relevant chemical.

On the proposal to have a future project based on imports, the WG chair observed that there was no obligation under PIC to notify on imports.

17.2.3 Mandate amendment/closure

The timeline for the completion of the "Tips and Hints" was amended and the Forum adopted the updated mandate. The Forum conditionally closed the mandate of the WG, as all the deliverables were expected before the next plenary meeting (Annex 2n).

17.3 Training for enforcement trainers 2018

17.3.1 WG final report

The WG chair presented to the Forum the statistics concerning the training event of 2018 that took place back-to back with the training for BPR inspectors. 69 trainees attended the training in ECHA and several remote connections were established. In the overall, 98% of the trainees rated the training as "excellent" or "good". The Forum adopted the final report of the WG.

17.3.2 Mandate amendment/closure

The Forum closed the mandate of the WG (Annex 20).

Item 18 – Update on relevant developments by the Commission 18.1 General updates by the European Commission

The Chair referred to the meeting documents for this agenda item. The COM representative informed that the programme for exchange of inspectors would continue throughout 2019. Some Forum members expressed appreciation for the programme, which was found very useful for the inspectors. It was suggested for the travel costs to be paid directly by COM rather than have them reimbursed later.

DG ENV was initiating the preparations for the REACH report from the Member States in 2020 by selecting a contractor. It was foreseen that Forum members would be consulted about the revised questionnaire. The Forum Chairs expressed regret about the absence of representative from DG ENV attending at that time of the meeting who could elaborate more on COM's plans on this subject.

18.2 ICSMS update

A COM representative gave a demonstration of the features of the current version of the ICSMS concerning REACH and CLP DRPIs and the potential of a statistic tool based on the information recorded by inspectors in ICSMS. Access to this tool could be given, upon request, from the list of users of ICSMS. The PIC DRPI was still under discussion and there was no foreseen date for its release.

Replying to the questions from the Forum member, the presenter informed that training on site was not provided. However, the Member States could use available pre-recorded trainings or via a live Webinar, that could be recorded for future trainings in the Member State.

Translated versions of ICSMS were not provided by COM but could be done by the national contact points, upon request.

Item 19 – Cooperation with other networks 19.1 Updates from SLIC-CHEMEX

A representative from the SLIC CHEMEX WG presented the ongoing activities of the network. She presented the new published guidance for national labour inspectors on 'Addressing health risks from welding fumes' and the future work of the long latency sub-group. Moreover, she informed that the translations of the interim CHEMEX guidance on 'How to use OELs, DNELs and DMELs when assessing effective control of exposure to chemicals in the workplace' were completed. The presenter highlighted the collaborative work with ECHA and the importance to continue the cooperation with the Forum.

The Forum welcomed the work of SLIC and highlighted that OSH interface with REACH was becoming more relevant (e.g. authorisation) and that further collaboration was envisaged in the Forum's MAWP. The Forum invited the participation of a SLIC expert in the WG 'OSH REACH Survey' and for SLIC to identify the areas where collaboration between labour and REACH inspectors was found important.

19.2 Update from CLEEN

The ECHA Forum Secretariat informed that a presentation on the activities of the Forum was given at the last CLEEN meeting (October 2018).

Item 20 - Updates from the ECHA and Forum Secretariat

20.1 Update on ECHA's strategic plan 2019-2023

The ECHA Forum Secretariat informed that the Forum comments were considered and coordination of enforcement was better reflected in the new draft of ECHA's strategic plan. The document will be adopted at the Management Board meeting in December.

20.2 Follow-up of ECHA Decisions: updates from ECHA

The Forum took note of the meeting document that included a summary table of the cases sent to the Member States Focal points.

20.3 Animal testing without testing proposals

The ECHA Forum Secretariat informed the members that ECHA prepared a new report identifying cases where animal tests were conducted for the purposes of a registration without a Testing Proposal. ECHA informed the NEAs about these cases of potential non-compliance and invited an investigation. ECHA will produce a public

report including the feedback from the NEAs at a later stage. The report will be consulted with the Forum before publication.

20.4 Update on ECHA Guidance activities

The Forum took note of the updates from ECHA Guidance. The Forum members were alerted on the divergent views regarding the Poison Centres Guidance. If no agreement was achieved in the current discussions, the guidance should include a "note to the reader" stating the minority position.

20.5 Forum indicators - wrap up

The ECHA Forum Secretariat informed that the Forum's feedback on the indicators document was collected and implemented. It was foreseen its adoption and publication of the document by the end of 2018. The revision of the indicators would be done on a yearly basis. COM welcomed the publication of the Forum's indicators.

20.6 Monitoring system for the flow and use of safe use information

The Chair referred to the meeting document that provided an overview of a monitoring system that was currently being developed under the ENES Programme to better understand the flow of extended SDS in the European market place. An implementation plan for the monitoring activities was foreseen to be prepared in 2019 and the first survey round to take place in 2020. The Forum took note of the monitoring system.

The Forum's ENES Contact Points were invited to keep the ENES Programme informed about any SDS related enforcement projects run during the monitoring period and coordinate as appropriate.

Item 21 – Updates on the cooperation between Forum and BPR Subgroup

The Chair of the BPRS informed about the outcome of the discussions during the BPRS-6¹ plenary meeting that took place before the Forum-31.

Item 22 - Updates on the follow up of ECHA's Evaluation decisions

The ECHA Forum Secretariat summarised the changes to the addressee policy that affected how ECHA will send the dossier evaluation (DEV) decisions to registrants as of 2019. As of that year, DEV decisions will be addressed to all members of the joint submission. The NEAs in the countries of all registrants will be informed about the non-compliance with any requests in the decision. The impact on NEAs on this change of policy will not be immediate and will be felt, at the earliest, in 2020, when the first deadlines of such decisions expire.

During 2019, the Forum will be invited to discuss how to handle the enforcement of such decisions and the need to cooperate between NEAs. Consequently, the interlinks guide should be reviewed during 2019 to reflect the possible changes in the process. It was foreseen that the DEV decisions process would become similar to the SEV decision process. The Chair noted that the Forum does not yet have much experience with SEV decisions as follow-up actions were needed for only very few SEV decisions. She suggested to set up a WG, in a future meeting, for the revision of the Interlinks document.

The Forum was also informed on the changes in ECHA's DEV follow-up process put in place to reflect the ECJ judgement on the SONC, discussed at Forum-30, that ruled that, when ECHA assesses the information submitted by registrants, the assessment must be done as a decision under Art 42(1), unless the submitted information is manifestly unreasonable.

The Forum members were invited to submit feedback on potential issues that may arise due to the upcoming changes in the addressee policy and on the revised follow-up process.

Item 23 - POP recast and the role of the ECHA Forum

The ECHA Forum Secretariat informed that the position of the Forum on this issue was conveyed to the European Council by the Executive Director of ECHA in July 2018. The new draft of the POP Regulation included the wording based on Article 76(1) of REACH. Similar to PIC, it gives the Forum a mandate to act with regard to the POP regulation as it does for REACH (based on the tasks defined in Article 77(4) of REACH).

The Forum agreed with the references to the Forum activities related to POPs, as included in the adopted MAWP 2019-2023.

Item 24 – Closing remarks by ECHA's Head of Unit of the Support, Forum and Helpnet Secretariat

ECHA's Head of Unit of the Support, Forum and Helpnet Secretariat shared his personal impressions about the open session and the active discussions that took place. He congratulated the Forum on the achievements of the meeting and wished success with the upcoming work.

Item 25 - A.O.B.

25.1 - Follow-up of a substance under SEV

A Forum member shared the fact that examination of a substance under the Substance Evaluation (SEV) process was taking place and that one of the registrants was required to submit tests results to allow the competent authority to conclude the evaluation. Involvement of the NEA from other Member States was needed to enforce that the registrant submits the needed data.

Item 26 - Closing of the meeting

The Chair thanked the participants, the COM and the ECHA Forum Secretariat for their contributions and support. With that, she closed the meeting.






