I. Summary record of the proceedings

Item 1 - Welcome and introduction

1.1 Welcome and opening by the Forum Chair

The Forum Chair welcomed all the participants and opened the meeting. She announced that the Forum members from the 27 EU Member States with voting rights and the three EEA countries were attending. The Chair informed that the quorum requirement was met.

1.2 Adoption of the agenda

The Chair indicated the changes in the agenda. The agenda was adopted (Content IV, <u>Annex 1</u>).

1.3 Declarations of conflicts of interest with regard to agenda items

No conflicts of interest were declared at the meeting according to Article 9(2) of the Rules of Procedure.

1.4 State of play with action points from Forum-38

The Harmonised Enforcement team (HET) informed the plenary on the status of the action points from Forum-38.

1.5 Results of the written procedures and other issues between Forum-38 and Forum-39

The Chair referred to the document with the results of the written procedures between Forum-38 and Forum-39.

Item 2 - Planning of Forum's tasks

2.1 Outcome of the survey on Forum participation and individual interviews with Forum

During the period between Forum-38 and Forum-39, the Forum Chairs contacted Forum members to identify the issues and possible solutions to increase the level of engagement of Forum members to face the increasing tasks of the Forum.

2.2 Draft Forum chapter of ECHA Programming Document 2022 – Result of the consultation with the Forum Chairs

HET summarised the planned activities of the Forum for 2022 featured in the draft ECHA Programming Document 2022-2025, which was consulted with the Forum Chairs. After the Forum-39 meeting, the draft would be amended to reflect the conclusions about the Forum's projects for 2022.

It was noted that the enforcement issues were scattered in the document and there was no dedicated chapter on the Forum. However, some Forum members expressed that it would increase the visibility of the Forum's work if there was a dedicated Forum chapter in the Programming document.

Item 3 - Forum's enforcement activities - Ongoing projects

3.1 Prioritisation of REF projects

3.1.1 WG progress report

The Forum agreed to initiate a pilot project focused on placing on the market and the use of the substance Dichloromethane (DCM) in paint strippers and the placing on the market and use of the substance N-Methyl-Pyrrolidone (NMP).

HET will update the registry of legal obligations in consultation with the WG.

Forum members were invited to submit proposals for REF-12 project by 13 April 2022.

3.1.2 Planning of future Forum's pilot projects

The Forum discussed the timing as well as duration of the upcoming pilot projects.

It was agreed that the pilot projects should last 18 months and additional 4-5 months for the follow-up phase. Thus, it would make it easier to plan and to make resources available at national level. Consequently, the manuals should be leaner and the projects with a limited scope.

It was also suggested for the work on the Enforcement guide for inspectors to start already during the operational phase, when the WG is less busy with tasks.

To increase efficiency, the workshop with ASOs (follow-up phase of the projects) could be combined with the yearly Open session, whenever possible.

3.1.3 Mandate amendment

The Forum adopted the updated WG mandate (Annex 2a). The WG has a rotating chair and a new chair needed to be appointed. However, no new chair was appointed.

3.2 REF-8 on Online sales

3.2.1 WG progress report

The Forum was informed on the latest activities of the WG.

3.2.2 Adoption of the project report

The WG chair presented three last changes in the report and the Forum adopted the report with those changes.

3.2.3 Mandate amendment

The Forum adopted the updated WG mandate (Annex 2b).

3.3 REF-10 on Integrated control of products

3.3.1 WG progress report

The WG chair summarised the WG's activities, that consisted of the preparation of the project manual and initiation of the draft enforcement guide for inspectors, which will be used as a working tool by the inspectors during the operational phase. The Chair requested for it to be consulted with the Forum before NCs were

informed. The final guide will be completed upon the conclusion of the project report.

The reporting tool used by the inspectors to record the national inspections will be the EU survey, for the first time used in a Forum project.

The WG was organising the remote training for National Coordinators and inspectors. The Forum agreed to invite Helpnet representatives to participate in the training event.

3.3.2 Mandate amendment

The Forum adopted the updated WG mandate (Annex 2c).

3.4 Enforceability of Restrictions

3.4.1 WG progress report

The HET member presented the work done by the WG and informed about the activities planned for the later quarter of 2021 and the year 2022. He briefed the Forum on the advices on enforceability developed between Forum-38 and 39.

He also invited the Forum members to take over the chairmanship of this WG, to appoint more invited experts and allocate time for them to perform their tasks.

The WG finalised drafting the document "Assessment of Enforceability of new REACH Annex XVII restrictions and analysis of Forum advice contribution to the development of restrictions" which included recommendations to improve the quality of the Forum's advice. The Forum members were invited to comment on the draft.

The Forum agreed with the recommendation of the WG to start the revision of the working procedure for the development of the Forum advice and support to RAC and SEAC.

A Forum member noted that the Forum advice was just a part of a lengthy process, taking place at ECHA and COM level. With that in mind, some Forum members welcomed the revision of the overall restriction process and to add a possibility for the Forum to revise the advice at a later stage in the process.

3.4.2 Mandate amendment

The Forum adopted the updated WG mandate (Annex 2d).

3.5 REF-9 on Authorisation

3.5.1 WG progress report

The Forum took note of the WG's progress report, focused on the WG activities supporting the operational phase of the project, which was ongoing until the end of 2021.

3.5.2 Mandate amendment

The Forum adopted the updated mandate (Annex 2e).

3.6 Pilot project on recovered substances

3.6.1 Mandate amendment

The operational phase of the project was running by the end of 2021. There was a Workshop with the National Coordinators and inspectors to discuss some practical cases.

The Forum adopted the updated WG mandate (Annex 2f).

I tem 4 - Update on relevant developments by the Commission

4.1 General updates by the European Commission

COM representative informed the Forum on the plans regarding the European Audit Capacity within the Chemicals Strategy for Sustainability (CSS) mandate and on the consultation with the Forum members. The starting of the audits itself was not yet planned.

The Chair invited COM to inform the Forum on the outcome of the study made by the contractor and on the interim report. Depending on the findings of the study, the Forum could be involved at a later stage.

4.2 Work on the Chemicals Strategy for Sustainability

4.2.1 Preparations for the High-Level Roundtable meeting

Stemming from the CSS, the COM's High-level Roundtable (HLRT) group would have their second meeting on 25 November 2021 and it would focus on enforcement.

COM prepared a background document, which was shared with the Forum. Moreover, delegates from the representatives of the participants of the HLRT group (Sherpas) were preparing the discussion topics to be addressed at the meeting.

4.2.2 Report on the preparations for the High-Level Roundtable meeting

The Forum Chair was invited by the HLRT group to make a presentation on the general overview of enforcement in the EU. One main message to pass on would be the need to increase resources at Member State level.

The Forum Chairs were invited to comment in writing on the document being prepared by the Sherpas for the HLRT meeting. The document was shared with Forum members to collect their feedback.

Forum members welcomed the input from the Chairs and confirmed the issues being brought to the HLRT were the main and most challenging ones. A Forum member highlighted also the importance of circular economy and its impact in substance legislations (*e.g.* Waste Framework Direction), as it would mean more cooperation with waste and REACH authorities and capacity building on both areas.

4.2.3 CSS WG 9 on Enforcement

The Working Group 9, created under the CSS, focused on enforcement. The participants of this group are restricted to appointed COM representatives (and its agencies, such as ECHA). However, COM will keep the Forum informed of its activities and any relevant issue for which the Forum's input was needed.

4.3 Debriefing of the meeting between COM and Forum Chairs

The first meeting of this nature tool place in September 2021. The objective was to introduce some topics and pre-discuss them before bringing them to the Forum.

Item 5 – Results of the Member State reports (Art 117.1 REACH and 46.2 CLP)

HET summarised the results of the Member States report from 2020. However, many members raised a concern about the continued lack of common convention for counting controls. If not addressed, it will also affect the Member States report due in 2025 (and the annual reporting pilot). Hence, it was proposed to re-open the WG Member State reporting, which was closed in 2020 due to lack of resources, to tackle this issue in particular.

The Forum agreed to re-open the WG Member State reporting (see agenda item 10.4) to seek agreement on common convention for Member States to count controls.

I tem 6 - Debriefing of the meeting with ECHA Directors

The Chairs informed the Forum about the discussions that took place during the remote meeting with the ECHA Directors, on 8 November 2021. The topics discussed were the 1) CSS and the preparations for the High Level round table meeting, 2) Forum's resources and, 3) Interact for BPR.

I tem 7 - Preparation for the Joint Open session

7.1 Welcome to the BPRS members

The Forum Chair welcomed the BPRS members joining for the meeting. The BPRS Chair opened the BPRS-14, which included the Joint Open Session.

7.2 Discussion of the lines to take

The Forum and BPRS members discussed the document prepared as background for the open session and agreed on the main messages for the presenting stakeholders.

Minutes of the Open session can be found in section 2021 Open Session.

Item 9 – Debriefing of the Open session

The Forum Chair welcomed the lively discussions that took place during the open session

I tem 10 – Forum's enforcement activities- Upcoming projects 10.1 REF-11 on SDS

10.1.1 Mandate set-up

The Forum adopted the created mandate for the WG managing REF-11 (Annex 2g).

10.2 Pilot project on classification of mixtures focusing on detergents and cleaning products

10.2.1 Mandate set-up

The Forum adopted the created mandate for the WG (Annex 2h).

10.3 Train the enforcement trainers 2022

10.3.1 Proposed topics for the training

HET presented the topic proposals collected from the Forum members. The Forum then agreed to set the focus of the next training event on SDS, to prepare inspectors for REF-11.

10.3.2 Mandate set-up

The Forum adopted the mandate (Annex 2i).

10.4 Member State reporting

10.4.1 Mandate set-up

The Forum adopted the mandate of the WG (Annex 2i).

I tem 11 – Update of ECHA screening of registrations to verify update duties

The Forum took note of the letter campaigns for registrants to verify the "correctness" of their dossier. Registrations where uses indicated were for non-exempted uses would be communicated to NEAs for further action at national level.

Item 12- Forum contribution to REACH Revision

HET summarised the latest changes in the Forum's list of suggestions for REACH Revision introduced on request by Forum members after Forum-38. The changes suggested by the Forum are proposed in order to facilitate enforcement.

COM welcomed the list prepared by the Forum and ensured it will be taken into consideration for the REACH review.

The Forum discussed the last-minute comments and editorial changes were done on screen. The Forum adopted the REACH Review list edited at the meeting.

Item 13 – Practical issues for enforcement of REACH, CLP, PIC and POPs

Forum discussed the current practical issues relevant to enforcement. Members were invited to submit new practical issues by 24 January 2022.

Issue 31.2 - Can resellers and other intermediate traders be part of a supply chain of creosote treated wood?

The issue was re-opened after the agreement with BPRS earlier in 2021 that all discussions on cross-legislation maters were to be handled by the Forum. Following

request from two members, the conclusion was expanded to address the interplay between REACH restriction entry 31 and BPR.

The Forum adopted the revised conclusion.

Issue 39.1 – Interpretation of CLP Article 35(2) concerning packaging with triggers containing naphta-based product, which might lead to the child resistant fastening ceasing to work

Forum adopted the draft conclusion proposed by HET considering the explicit requirement of CLP Article 35(1)(b) that package is not affected by contents and standard EN ISO 8317: 2015.

Issue 39.2 – How do inspectors react when aerosol dispensers placed on the market do not meet the requirements of standard EN ISO 11683: 1997?

HET addressed all comments received from the consultation and drafted the conclusion. HET will contact the European Aerosol Federation (FEA) to further inquire about the requirements for the tactile symbols for spray direction.

The Forum decided to have an additional commenting round of the draft conclusion and to assess the feedback from the FEA.

Issue 39.3— How can the NEAs practically implement the approach to classification of aerosols expressed on Q&A 1456?

The draft conclusion proposed a common approach to implement the CARACAL conclusion to avoid a risk of a non-harmonised approach to aerosol classification controls. The Forum agreed to another written consultation before adopting it by written procedure.

I tem 15 – Enforcement in the Member States

15.1 Market Surveillance of imported chemical products used in motor factor sector for compliance with REACH and CLP

The Irish expert presented the national project focused on products used for car cleaning, car repair, fuel treatment, etc. The project run in 2021 and it found, amongst others, that many imported mixtures from non-EU countries were non-compliant. This project was also an important awareness-raising for SMEs as it was noted that Irish downstream users and distributers relying on the supply from the UK were, after 1 Jan 2021, importers and were not always aware of their new legal responsibilities.

15.2 Enforcement perspective on communication in supply chain

The Forum Chair referred to the presentation done by the NO Alternate member for BAuA's REACH2SDS seminar on "Enforcement perspective on communication in supply chain." It included the results of Forum's REF-5 and ASO-joint projects, and some national perspectives from inspectors on Exposure scenarios.

It was recommended for the WG REF-11 to take such information into consideration when preparing the project manual.

I tem 16 – Updates from the ECHA Harmonised Enforcement team

16.1 'Access to documents' requests

HET summarised the status of the received access to document (ATD) request during the summer. The final reply to the request would be sent to the Forum by HET.

16.2 Pilot exercise on the Member State annual reporting on enforcement to ECHA

A pilot in annual reporting originated from actions identified in REACH review 2017. In 2018, the Forum agreed to set up a pilot exercise to collect annual national enforcement data from the volunteering countries, during the course of two years. HET proposed to start this pilot in 2022. However, the Forum noted that it lacked a harmonised convention of counting controls for purposes of reporting. This would undermine the data collected in the pilot exercise and Forum members were reluctant to run this pilot in such time frame.

Since the <u>WG Member States reporting was re-opened</u> to reach agreement on a harmonised convention to count "control", the Forum discussed the potential timelines for the pilot.

HET highlighted the reason for not waiting for the harmonised counting convention was that the pilot was included in the Forum work programme, which should be delivered by 2023. Moreover, if the convention is agreed in 2022 and used for collecting data for 2023, this would allow to compare how far the new convention changes the results from 2022 to 2023.

The Forum agreed not to run the pilot in 2022 and re-visit this issue at Forum-42 (November 2022).

16.3 Enforcement implications of UK withdrawal

This item was not addressed at the meeting.

16.4 Follow-up of ECHA Decisions: updates from ECHA

The Forum took note on the information about the cases sent to the Member States Focal points until 15 Oct 2021.

16.5 Reporting tool of Forum's projects

The presenter informed the Forum on the foreseen use of EU Survey as the tool to substitute iPDF when collecting the findings of the inspections in Forum's projects. After the needed commenting rounds, HET developed three options to address the challenges indicated by the Forum members. The tool was presented to the WGs managing the projects that will use the tool in 2022 and the feedback was positive.

It was recommended for countries that chose not to use EU Survey and use individual reporting tools, to report the data in the same report template provided by HET. It would allow to agglomerate their results with the results from other countries using EU Survey. Otherwise, there was a risk that WG or HET would not have the resources to revise and adjust the data set to the correct format.

The Forum members selected the option that best served their needs, with one country indicating that it was not possible to use the EU survey and will pursue the possibility to prepare their own national tool.

HET also highlighted the new functionality that allowed the possibility for the answers to be reviewed by a second user before finalising the survey, by saving it as draft and send it to the reviewer.

HET would deliver an *ad hoc* remote training focused on the knowledge needed to operate the EU survey. Feedback from National Coordinators on the use of this tool will be collected at the end of 2022 for HET to assess how to improve the experience. The practical cases used in the training will be shared with Forum members to be used in their national trainings/tool set-up, as needed.

I tem 17 – Cooperation with other networks

17.1 Potential work of the Forum with the European Anti-Fraud Office (OLAF)

After Forum-38, the Forum members were invited to provide feedback on the Forum's potential collaboration with OLAF.

Some Forum members expressed their interest in working with OLAF. The Forum agreed to wait until COM clarified the changes in the remit of OLAF that may affect the cooperation with the NEAs, which was a measure proposed under the work of CSS. In the meantime, HET would liaise with OLAF and discuss potential examples for cooperation between NEAs and OLAF that could be established in the future.

17.2 Forum's contribution to the Product Compliance Network (EUPCN) and the ADCO Chairs' meetings

The Forum took note of the information from the EUPCN meetings, EUPCN partner group on ICSMS and ADCO chairs meeting attended by the Forum Chairs.

The Forum Chairs have been collecting the Forum members' feedback on an *adhoc* basis and would continue this practice when needed.

In the ICSMS partner group, the priority work was to increase the quality of the future data reported in ICSMS by enhancing the usability of the tool for inspectors and potentially improve the quality of the existing data. The Chair thanked the participants that volunteered to be part of the practical exercise with ICSMS.

In case it was needed to discuss enforcement topics raised by Forum members related to Market Surveillance regulation, it could be done at the Forum meetings with the participation of the relevant COM representative.

On the European Union Testing Facilities (EUTFs), EUPCN selected Toys and radio equipment to start a pilot to create the EUTFs. Toys could include the cooperation with REACH but priorities on the technical specifications needed to be done. Due to the timeline of the exercise, starting by having the legislation in place to set it up, it was most likely that it would not impact REF-10 inspections.

17.3 Updates from SLIC-CHEMEX

The Forum took note of the information provided in a meeting document with the updates of the SLIC-CHEMEX's work since June 2021. At its last plenary meeting, a new chair and co-chair were selected. The WG has changed their way of working

and have a main group and two sub-groups, one continuing to deal specifically with long latency issues e.g. occupational carcinogens, and the second sub-group will address REACH/OSH issues. HET representative will participate as an expert in the main group.

The Forum mandated the WG Train for trainers 2022 to consider the involvement of CHEMEX in the preparation of the training event.

Item 18 - Updates from BPR Subgroup

The BPRS Chair briefed the Forum on the issues to be discussed in the BPRS-14 plenary meeting¹.

Item 19 - A.O.B.

19.1 Consequences of the judgment case C-663/18 (Cannabidiol)

The presenter highlighted the judgment in Case C-663/18 (19 November 2020), where ECJ considered Cannabidiol (CBD) as no longer a "narcotic drug". If CBD was authorised, the CBD-based vaping products would fall within the scope of tobacco products as well as in the scope of the regulations applicable to chemical products. Therefore, that substance was no longer exempt from registration and should be subject to enforcement accordingly.

A Forum member reported that there were not many experiences with such cases, but would pursue it in the future. The Forum members were invited to share their experiences with CBD.

2021 Joint Forum-BPRS Open session (10 November 2021)2

I tem OS 1- Welcome and Introduction to the open session

The Forum Chair, on behalf of both Forum and BPRS, welcomed the 34 representatives of 26 ECHA Accredited Stakeholders (ASOs) participating in the meeting. She welcomed the six observers representing three countries benefiting from the Instrument for Pre-Accession Assistance (IPA) programme.

I tem OS 2 – Updates from the Forum/BPRS OS 2.1 Update on the scope of upcoming REF/BEF projects

The participants were informed that the Forum selected the harmonised enforcement project REF-11 on SDS with operation phase in 2023. The preparation of this project will start in 2022. Additionally, the Forum selected a pilot project on restricted substances with impact at workplaces, tackling the placing on the market and use of Dichloromethane in paint strippers and the placing on the market and use of N-Methyl-Pyrrolidone.

ASOs were invited to submit proposals for the next enforcement project on REACH/CLP/PIC/POPs, REF-12, by 13 April 2022.

The participants were also informed about the plans for projects to be run in the BPRS, in particular BEF-2, which will focus on the control of biocidal products and approved active substances. The WG has prepared a manual in 2021 and the inspections will start in 2022.

ASOs were invited to submit BPR topics for the next BPR enforcement project (BEF-3) by April 2023 or approach HET whenever needed.

OS 2.2 Projects and related activities finalised during 2021 OS 2.2.1 REF-8

The WG chair presented the results of the project REF-8 on online sales and informed that the report would be published in ECHA's website in December 2021³. The main non-compliances found were: 78% for REACH Restrictions; 5% REACH Article 31(1)(3)/(5); 75% CLP Article 48 and 77% BPR (more details in the report).

She informed that the follow-up of the project will consist in organising a dedicated workshop, in Q2 2022, with the main stakeholders addressed in the project. The objective of such workshop was to discuss the recommendations and brainstorm on ways to improve the situation and issues found in the project.

An ASO representative noted that the results of the project were not surprising and similar findings have been encountered by the members of his organisation.

The WG chair clarified that inspections of the REF-8 project did not include a follow-up to check whether the non-compliant product reappeared after being taken down by the marketplace. There had been some work developed by COM with the use of artificial intelligence (web crawlers), which identify similar products.

Other ASO representative highlighted that most likely the non-compliant companies were the ones not members of a trade association/organisation.

Replying to a participant, the WG chair clarified that the report did not include sector-specific information and there will not be any review of the report in the future.

It was suggested for the consumer organisations to follow-up on the findings of the report by liaising with the national authorities. It was noted that sanctioning was not the enforcement action mostly used by the inspectors in such cases and it was mainly due to national procedures and the need to evaluate the severity of each case by the inspectors.

OS 2.2.2 ASOs Workshops related to the projects Customs 2, REF-7 and BEF-1

The Forum Chair summarised this new activity of the Forum's projects, which brings together the interested Stakeholders and the WG managing the project to discuss the findings and recommendations, ideally agreeing on an action plan to help improve the situation in the future.

There were three remote workshops held in 2021 and the participants found the workshop very helpful and instructive.

Item OS 3 – Discussion topics proposed by ASOs

OS 3.1 Enforcement of in-situ generated Biocides - European Ozone trade Association (BPR)

The presenter introduced the 'in-situ generated biocide' and its challenges for the enforcement of the BPR. In particular, the devices present in the market used for the generation of the active substance that will be 'orphan' devices, approved devices and non-approved devices. The issue would be relevant in the years to come and there was a lot of work still to be done to ensure the level playing field in this area.

The BPRS Chair informed that enforcement is an exclusive competence of the Member States for all chemicals legislation and Forum is not a central enforcement "Agency", nor could it take on the tasks described in the presentation.

At present, the BPRS had no experience in addressing duties related to *in situ* generation. BPRS took note of the concern and will take action to collect the experience of the BPR NEAs with ozone generating devices and consider if there is a widespread compliance problem. Some BPRS members shared their national experiences.

BPRS indicated that EUOTA could submit a list of duty holders or products which generate ozone *in situ* considered to be breaching the BPR duties. The BPRS would consider whether and how to take such information forward and respond to EUOTA.

OS 3.2 How would future enforcement activities work in practice: enforceability of broad restrictions and revocation of registration numbers – Cefic

The presenter highlighted the ambition of CSS to raise the regulatory bar and to prioritise enforcement. Enforcement is a matter of people's safety and a non-compliant product poses a serious health and safety risk to consumers. Furthermore, enforcement is a matter of competitiveness and level playing field and "free riders" should not be allowed to bypass EU rules. In particular, in products purchased online, most from "unknown" countries, it was still possible to find concentrations of the restricted substances much higher than the limit values.

Cefic welcomed EU's ambition to step up enforcement and questioned whether there was a process in place to enforce revocations.

The Forum was supportive of the proposals from the CSS and welcomed further development by COM on the highlighted areas to improve enforcement.

The Forum/NEAs have in place a process to enforce revocations detected by ECHA, for example, during the SME verification. That same process can be used for general revocations, if introduced in the next REACH revision.

The Forum Vice-chair added that it was impossible for NEAs to check all products for restrictions and have to set priorities at national level. It could be one area that it could be beneficial to liaise with the sector organisations to have intelligence of the products that enforcement could focus on.

Some ASOs and Forum members shared their experience with broad restrictions and its enforcement. It was referred to the Forum Compendium of analytical methods⁴, which is often used by authorities and in the advice of enforceability of restrictions by the Forum.

OS 3.3 Consistency of enforcement between Member States - Photoinitiator Platform

The presenter highlighted the issue of harmonisation of enforcement in particular regarding the ORs and their responsibility in the supply chain for the SDS and ORs. In his view, REACH and the guidance documents lays down requirements and processes for compliance. However, the presenter alleged that the Member States do not have the same interpretation on these requirements.

The Forum discussed the OR's responsibility for SDS at length in the past. The REACH supply chain communication model does not provide explicit rules for responsibility of OR and importers that they cover. The Forum is working on a conclusion for this issue that will give a clear line for NEAs to follow in a harmonised way. The Forum hoped that OR's duties related to SDS will be explicitly clarified in legal text during the upcoming REACH Revision – this was suggested to COM's services.

NEAs can only act when a clear breach of the legal duty has been identified and inspectors can gather proof. A "postbox OR" is usually not illegal – national legislations that define requirements for establishment of companies usually require an address not an office. A relevant criterion is the existence of the company. In some situations, where NEAs can confirm that a company fails to meet

the requirements for existence under the national law, they can then take action and ECHA can revoke such registration.

The control of quantities corresponding to tonnage band is one of the standard checks when controlling registration duties by NEAs. In case there is knowledge that the tonnage band was exceeded, it should be reported to the respective NEAs.

HET added that ECHA does not have the legal mandate to re-assign the role of the lead registrant and that was left for the members of the joint submission to discuss and take legal action in national courts. On the quality of data in the dossiers, HET informed that ECHA and NEAs have a robust process in place for the enforcement of dossier evaluation decisions.

Other issues brought by the presenter were out of the scope of the Forum and he was advised to contact ECHA Secretariat.

OS 3.4 Consumer organizations as core partners in a zero-tolerance approach to non-compliance – BEUC

The presenter referred to the CSS and its zero-tolerance approach to non-compliance, as well as empowerment of consumers and consumer organizations as their behaviour is a powerful driver to ensuring compliance with legislation.

The participants were informed on the activities of the International Consumer Research & Testing (ICRT), a global consortium of consumer organisations that collaborate on research and testing of consumer products.

The Forum Chair thanked the valuable work that consumer organisations do across the EU and for helping raising awareness of the findings of enforcement authorities about unsafe products. She highlighted that CSS calls for greater cooperation between enforcement and civil society organisations and the Forum would welcome exploring possibilities for further cooperation.

Testing products is critical part of enforcement and NEAs resources for analytical tests are limited as well as there is limited capacity to follow up intelligence from consumer organisations.

Hence, in order to promote cooperation between NEAs and consumer products in the future, ideally during the operational phase of REF-10 that deals with consumer products, it was proposed for national consumer organisations and NEAs to liaise at national level and discuss the potential cooperation. The feedback on these contacts would be discussed in the upcoming Forum meeting and communicated to BEUC.

OS 3.5 Planning progress on Market Surveillance, from REACH4textiles project, to the CSS to Member States

The presenter informed the participants about the organisation and their concern with the new REACH restrictions on textiles and its enforcement in the different Member States. There are a great number of products under these new restrictions and it would be impossible for NEAs to check them all. The presenter welcomed the changes in the Market Surveillance regulation and the work to be done under the CSS, combined with more Forum projects and actions from industry as steps towards the enhancement of the effectiveness of the enforcement of restriction.

The "REACH4textiles" project was supported by COM and it was an effort to scale up improvement on market surveillance across industry and in the scope of CSS. Volunteering Forum members were invited to participate in its advisory board.

The Forum welcomed the project of the textile industry associations and looked forward to its results that will facilitate control of textile products.

I tem OS 4 – COM report on the REACH and CLP enforcement indicators

The DG GROW representative gave a brief introduction of CSS and its main five areas related to enforcement that will be addressed. He then presented the findings of COM's report on the EU Enforcement indicators, highlighting the results of the 13 EU level enforcement indicators calculated from the period of 2007-2019. Interpretation of the figures was a work still ongoing in the COM and will be used in the upcoming REACH/CLP revision.
