# I. Summary record of the proceedings

#### Item 1 - Welcome and introduction

The Chair of the BPRS opened the plenary meeting which was held for the first time in hybrid mode, namely 17 members joining in person and 12 members remotely.

The Chair informed the plenary that the meeting was recorded for the purpose of writing the minutes, and that the recordings are going to be destroyed after the minutes are adopted.

The final agenda was adopted (see Annex I) with one AOB concerning the results of the Forum/BPRS satisfaction survey.

No conflicts of interest (according to Article 9 of the Forum Rules of Procedure) were declared at the meeting.

The ECHA Harmonised Enforcement Team (HET) informed the members that six room documents were submitted after the documents deadline, namely on: i) the BEF-2 Progress Report; ii) the Training for national inspectors Progress Report; iii) the REF-8 Progress Report; iv) the BPRS Practical Issues; v) the update from ADCO Chairs meeting and the EUPCN; vi) the Forum/BPRS satisfaction survey.

All action points from the BPRS-15 were discharged.

The Chair informed the members that the meeting among the Forum/BPRS Chairs and ECHA Director is going to take place on 15 June. Main topics to be discussed focus on ATD request from external parties, transparency, and the European Audit Capacity.

# Item 2 – Cooperation with ECHA bodies / Secretariat Update on Forum Work Programme 2021

# 2.1 Follow-up: EuOTA list of "non-compliant in situ devices" and experience in national enforcement

The Chair debriefed the plenary on the experiences shared by two Member States in monitoring and enforcing the concerned devices included in the list submitted by the European Ozone trade Association (EuOTA).

Some BPRS members reported to the plenary their intention to investigate in the coming months different devices mentioned in the list.

Based on the overall inputs to be collected by the BPRS-17, the BPRS might evaluate the need for broader actions to be taken at EU level.

# 2.2 Information about work of ECHA Biocides Assessment Units and its relevance for enforcement

The Head of Units from the ECHA Risk Management Directorate presented to the plenary the main roles of ECHA under the BPR, the activities of the two dedicated biocides units (i.e. Biocidal Active Substances - D1, and Biocidal Products - D2), the current work of the Biocidal Products Committee, and the ECHA dissemination portal for biocides.

The presentation aimed at enhancing the cooperation between the BPRS members and the ECHA operational Units. Follow-up discussions concerning dissemination for enforcement authorities and information related to Article 95 and 94 of the BPR might be tabled during the next BPRS plenaries.

## Item 3 - Updates on developments by the European Commission

#### 3.1 Update from DG SANTE

The DG SANTE representative delivered an update of the Commission's activities that were relevant for the work of the BPRS. The presentation started with the current work related to in situ biocidal products and active substances. Specifically, the speaker reported to the



members the case of the approval of ozone and the applicability of Article 19(4) of the BPR to this case. Information on the discussions concerning classification of active substances generated in situ was also shared with the members.

The Commission representative updated the BPRS members on the labelling of carry-over preservatives in detergents (as per the ongoing revision of the Detergents Regulation); and the state-of-play concerning the CA discussions on the wording of P-statements in SPC.

Other updates from DG SANTE were related to future considerations related to mutual recognition procedures for biocidal products, and to the technical assistance to Member States. In particular, the systematic delays in the procedures under the BPR and in the completion of the Review Programme led the Commission to consider offering the possibility for Member States to apply for grants. That would allow Member States to improve their efficiency in assessing application dossiers for active substances and biocidal products. Further discussion on the matter will take place among ECHA, EFSA and DG SANTE over the next months.

#### Item 2.bis Update from the Forum-41

The Forum Chair debriefed the BPRS members on the key issues to be tackled at the forthcoming Forum-41 plenary meeting to take place on 15-17 June. The update touched upon the REF-12 scope to be selected among the following topics: 'chemical compliance of imported goods', 'registration duties relevant to updated requirements and other follow-up requirements', and 'online sale'.

The speaker reported to the members the ongoing discussions concerning 'transparency of Forum advice on the enforceability of restrictions'; the preliminary results of the REF-9 on authorisation; and the scope of REF-11 on SDS.

Regarding the pilot project on classification of mixtures, the Forum Chair updated the plenary on the analysis performed by the Working Group members together with the ECHA experts and DG GROW on the interpretation of the CLP and its application for the evaluation of national cases of mixture classifications (as submitted by the Forum members by 30 June 2022). ECHA experts might potentially draft an *ad hoc* guideline on mixture classification once the ongoing CLP revision will be finalised.

Other updates were related to the next Forum Training for national inspectors (TfT) to be focused on SDS; and on the ongoing discussions related to the European Audit Capacity under the Chemicals Strategy for Sustainability.

Finally, the Forum Chair mentioned that a break-out-group session will take place at the Forum-41 to discuss on potential improvements concerning Forum plenaries and other processes related to Working Groups and their deliverables.

# Item 4 - BPRS enforcement activities

#### BEF-2

The WG Chair updated the plenary on the BEF-2 on-going activities. The operational phase of BEF-2 was kicked off in January 2022 and national inspectors are currently performing enforcement activities in 26 Member States plus Norway, Iceland, Liechtenstein and Switzerland. The scope of the BEF-2 focuses on biocidal products containing non-approved/approved active substance (under BPR and under national legislation). The project includes horizontal obligations such as Article 95, advertisement, labelling and packaging. Ad hoc sections on disinfectant products and chemical analysis are also expected.

The speaker introduced to the plenary the agenda of the BEF-2 workshop to be held on 14 June afternoon, back-to-back to the BPRS-16. The event will involve the National Coordinators of the BEF-2 together with the BPRS members and the BEF-2 Working Group members. Break-out group sessions will facilitate the discuss on the state-of play with BEF-2 national inspections; main challenges with the BEF-2 manual and questionnaires; the use of EU Survey; chemical analysis on biocidal products; legal aspects of the BEF-2;



and the use of the ECHA dissemination website for biocidal products. A summary of the discussion might be elaborated by the Working Group members as outcome of the event. Finally, the speaker invited the BPRS members and NCs for the BEF-2 to liaise with the WG members and HET in case of questions related to the BEF-2 manual and questionnaires.

#### BPRS Training for national inspectors 2022

The preparatory phase of the 5<sup>th</sup> BPRS training event to be held under the umbrella of the BPRS was kicked off in May 2022. The draft agenda was adopted at the BPRS-16. The event will be delivered remotely on 2 December 2022, and it will be focused on CLP for biocides, in situ generating systems, and BPR borderline issues. Over the next months the Working Group members will elaborate the presentations and case studies to be presented during the training event. The collaboration with ECHA experts and DG SANTE was successfully established.

#### REF-8

A BPRS member participating to the REF-8 WG informed the plenary that the Forum adopted the document "REF-8 Practical Guidance for enforcement", and that the WG organised an *ad hoc* workshop with the ECHA accredited stakeholders (ASOs) on 17 May 2022 (publication of the proceedings on ECHA website expected during July 2022). The workshop had the participation of 26 representatives of 11 Marketplaces and companies trading online, and 12 representatives of seven ECHA's ASOs, including the address by one Member of the European Parliament. During the workshop, the presentation from Commission on the CLP revision and the Digital Services Act raised some interesting issues and discussions. In particular the main questions from the participants touched upon the liability exemption for intermediary services; the distinction between the terms online "offer" and "advertisement", and their references to the Article 48 of the CLP.

The speaker reported to the plenary that the Working Group tasks as reported in the mandate were completed, and therefore the Working Group will be closed during the Forum-41.

#### Item 5 - Practical issues for enforcement

Two ongoing BPRS Practical Issues were analysed: i) legal aspects of the word 'vegetal' on biocidal product labels (i.e. Practical Issue BPRS-15.1); and ii) authorised rodenticides sold to non-professional users (i.e. Practical Issue BPRS-16.1). The BPRS members were invited to send to the HET their written comments as discussed at the plenary. The HET was then requested to revise the concerned draft conclusions and initiate follow-up rounds of consultations among the BPRS members and DG SANTE.

The BPRS members decided to close the pending Practical Issue BPRS-14.1 on in situ generated systems. Since discussions at the CA level are still ongoing, the originator of the Practical Issue was invited to resubmit the concerned draft conclusion, once more clarity on authorisation processes will be clarified and its relevance for enforcement activities need to be discussed within the BPRS.

# **Item 6 - Activities in Member States and cooperation with other networks**

# **6.1 Update from ADCO Chairs meeting and European Product Compliance network**

The Chair informed the plenary that four relevant meetings were held since the BPRS-15 namely: the EU Product Compliance Network (EU PCN) meeting n. 10 and 11; the *ad hoc* EU PCN on EU Testing Facility procurement; and the ADCO Chairs Meeting.

The topics tackled at those meetings touched upon: i) the guide for 'shopping under a cover identity' (document to be finalised in July 2022); ii) the new 'Blue Guide' on the



implementation of EU product rules 2022 (publication expected in June 2022); iii) the 'Peer Reviews' under Article 12 of the Market Surveillance Regulation.

# 6.2 Dutch case analysis - incidents with the use of phosphine in plant protection products and biocides

The Dutch BPRS member presented to the plenary a case analysis on incidents related to the use of phosphine contained in plant protection products and biocides. The presentation focused on the causes of the concerned incidents; the fumigation processes for foodstuffs, animal feed and raw material; the gas forming phosphide pills/pellets/tablets; and the handling of the concerned incidents. Solutions and directions of the problems were also presented and discussed among the BPRS members.

BPRS members were then invited to send questions and comments to the Dutch representative by 1 July 2022.

### Item 7 - AOBs

#### 7.1 Forum-BPRS Satisfaction survey

The discussion was postponed to the BPRS-17. A relevant document was made available among the BPRS members to provide written feedbacks after the plenary.
