I. Summary record of the proceedings

Item 1 - Welcome and introduction

1.1 Opening by the Chair of the Forum

The Chair welcomed all the participants. She announced apologies from the Liechtenstein Forum member and stated that Iceland and Latvia did not have Forum representation. No proxies were appointed.

The Chair informed that the quorum requirement was met.

1.2 Adoption of the agenda

The Chair indicated the changes in the agenda (Content IV, <u>Annex 1</u>). The agenda was adopted.

1.3 Declarations of conflicts of interest with regard to agenda items

The Chair requested all participants to declare any potential conflicts of interest for any of the agenda items, according to Article 9(2) of the Rules of Procedure. No conflicts of interest were declared in the meeting.

1.4 State of play with action points from Forum-21

The ECHA Forum Secretariat informed the plenary on the status of action points from Forum-21 and highlighted the open actions.

1.5 Practicalities and brief recapitulation of results of the written procedures between Forum-21 and Forum-22

The ECHA Forum Secretariat referred to the document with the results of the written procedures between Forum-21 and Forum-22.

Item 2 – Address by ECHA Executive Director

ECHA's Executive Director highlighted the REF-5 project focusing on extended Safety Data Sheets, exposure scenarios, risk management measures and operational conditions. He considered it as an important project addressing obligations previously unexplored by REACH enforcers in a coordinated way, but which determines the safety and health of workers in entire supply chains of the manufacturing industry in the EU.

He also encouraged the Forum to support the pilot projects proposals on internet sales of chemicals and obligations related to substances in articles, which were very relevant in the current climate.

During his visits to Ireland and Malta, he was able to testify the appreciation of the Forum's pilot project on child resistant fastenings for the added value it brought in protecting the general public. He was hopeful that the project would help to improve compliance with the requirements for child resistant fastenings and by this reduce the number of accidents.

The Executive Director and Directors were interested in the results of the REF-3 project and looked forward to the report soon after the plenary.

The Executive Director also addressed the discussion about the board of appeal decision on SONCs and its implications. ECHA was of the opinion that the decision did not affect the National Enforcement Authorities and inspectors might continue

to enforce the dossier evaluation decisions based on all existing SONCs. The BoA decision would mostly affect ECHA and the way it conducts the internal follow-up of dossier evaluation decisions. This issue would be discussed at the CARACAL-meeting and the Forum will be informed.

He informed that ECHA continues to be committed to supporting National Enforcement Authorities in the new Portal Dashboard for National Enforcement Authorities. In the future, ECHA will continue to expand the scope of data available in it.

Item 3 - Forum's enforcement activities - Work Packages

3.1. REACH-EN-FORCE-5

3.1.1 Task Force progress report

A Task Force member presented the proposed scope of REF-5 that will focus on verifying the consistent handling of key information on safe use in the supply chain, namely on extended Safety Data Sheets (SDS), exposure scenarios, risk management measures (RMM) and operational conditions (OC).

The Task Force included in its report the REACH articles that could be investigated by the inspectors as well as the target substances and groups. Since the safety of the workers was under scrutiny with the investigation of the OC and RMM to ensure adequate control of risk, the Task Force supported joint inspections with authorities responsible for the occupational safety and health inspections. This project could also be used to monitor if the companies had a reliable system in place for managing information of safe use of (generate, maintain, communicate etc. the extended SDS from their Chemical Safety Report).

The Forum agreed with the proposed scope for the REF-5 project and for it to cover safe use by end users. The Forum appreciated the idea to "cluster" the target groups in order to facilitate the focus and organisation of the inspections at Member State level.

3.1.2 Mandate amendment

The mandate of the Task Force was updated and the Forum adopted the updated mandate (Annex 2a). No Chair was appointed, thus the work for this project would continue to be executed and managed by means of a Task Force until Forum-23.

3.2 Prioritisation of REF projects

3.2.1 Update on the court ruling regarding 0.1% threshold for SiA

A representative from ECHA legal unit presented a summary of the judgment of the Court of Justice on substances in articles (SiA) (case C-106/14).

As reply to a Forum member, the ECHA legal unit representative informed that the judgement was not clear regarding the text "information available to the supplier", stating that the duty was in line with the principle of proportionality. However, given the objective of that provision (to enable the operator to have this information in order to take risk management measures), the legal representative was of the opinion that, upon request, the supplier would need to provide at least the name of the substance of very high concern (SVHC). ECHA Guidance would provide information on the ways to find whether the article contains SVHC. ECHA informed that its Guidance will be updated in two stages. A fast track update would align the document with the Court decision still in 2015, while a fully comprehensive update including new examples would be produced by the end of 2016.

3.2.2 WG progress report

The chair of this WG presented the WG proposal regarding two potential pilot projects based on the Forum's comments after Forum-21. The Forum agreed with the WG to initiate a pilot project on "Advertisement of hazardous chemicals" (focusing on e-commerce and article 48 CLP) in 2016 and another pilot on substances in articles in 2017.

The Chair recommended for the responsible ECHA colleagues (and volunteer Forum members) to present the project proposal on "Advertisement of hazardous chemicals" for adoption at Forum-23, this way enabling the operational phase to be conducted still in 2016.

The Substance in Articles project would be initiated in 2016 and a WG would be constituted during that year.

This WG Prioritisation finalised a registry that included the information on all the articles covered by the Forum REFs and pilot projects. It will be a valuable tool to keep track of the enforceable duties covered by Forum projects.

The WG Prioritisation discussed and proposed a number of points to improve the prioritisation's methodology and consequently to revise the REF project methodology (adopted at Forum-16). As part of this revision, the WG proposed to be mandated to assess previous projects manuals and reports in order to derive some guidelines for inspectors that could be incorporated in the revised methodology. The Forum agreed with the WG proposal.

3.2.3 Mandate amendment

The mandate of the WG was updated and the Forum adopted the updated mandate (Annex 2b).

3.3. REACH-EN-FORCE-4

3.3.1 WG progress report

ECHA Forum Secretariat presented the state of play of the project, on behalf of the WG, as the Forum membership of the WG chair has expired.

The WG was also tasked to investigate how to sustainably resolve the difficulties encountered with handling the data in REF projects. ECHA Forum Secretariat proposed to elaborate a basic report, reflecting the data collected. In order to expedite the elaboration of the report, it was advised that the questionnaire should be initially prepared in a simple way, focused on the important messages for which data should be collected and avoiding as much as possible cross-interpretation. REF-4 WG agreed with this approach and it would prepare the manual/questionnaire in that way.

The meeting was informed that the project plan was shifted one month due to the period invested in the final decision on the scope of the project and the reduced time to elaborate the manual during 2015. Vice-Chair suggested for the WG to consider shortening the operational phase by one month instead of shortening the reporting phase since this task usually takes more time than expected.

Some Forum members requested more time to appoint their national coordinators.

3.3.2 Mandate amendment

A Forum member volunteered for chairing this WG. The mandate of this WG was revised and the Forum adopted the updated mandate (Annex 2c).

3.4 Projects on authorisation

3.4.1 First pilot project: WG progress report

The WG chair informed the Forum that the operational phase finished at the end of June 2015, data from national coordinators was collected and the report was being prepared. He informed that also some desktop inspections were reported to the WG. However, the project manual stated that only on-site inspections should be reported. Therefore, the results of the desktop investigations will be included in the report but would not be analysed in much detail.

3.4.2 Second pilot project: WG progress report

The WG chair informed the meeting that the project manual was adopted and will be the basis for training the national coordinators.

3.4.3 Mandate amendment of first and second pilot project

The mandates of the WGs were revised and the Forum adopted the updated mandates (Annex 2d and Annex 2e, respectively).

3.5 Training for enforcement trainers 2015

3.5.1 WG progress report

The chair of this WG presented the results of the satisfaction survey collected for the training event that took place in ECHA during 24-25 Sept 2015 on the classification of mixtures (physical, health and environmental hazards) and labelling and packaging of mixtures. It was the first time that HelpNet members participated (both as trainers and trainees), which was regarded as a very positive experience and a good example of making best use of existing synergies within the Agency. A Forum member suggested for HelpNet members to consider involving Forum experts in their trainings.

A Forum member questioned if there would be a follow-up survey for the enforcement trainers to collect their feedback on the training sessions in their home country. ECHA Forum Secretariat informed that the 2015 satisfaction survey included questions related to the training event from 2014, to see whether training was still considered effective after one year.

The Forum adopted the report of the WG.

3.5.2 Mandate amendment

The mandate of this WG was revised (Annex 2f) and it was closed since all activities were completed.

3.6 Training for enforcement trainers 2016

3.6.1 WG progress report

The chair of this WG presented the activity plan and the topic proposal for the 2016 training event.

The Forum agreed with the WG that the next training should focus on issues related to the REF-5 project, i.e., extended SDS, exposure scenarios, risk management measures and operational conditions. Due to the nature of the topic, the Forum agreed to invite a member of the SLIC-CHEMEX to participate in this WG.

The Forum also agreed to continue the collaboration with HelpNet members.

3.6.2 Mandate amendment

In order to facilitate the cooperation, members of the REF-5 WG were also appointed as members of the WG training for enforcement trainers 2016. The mandate of this WG was revised and the Forum adopted the updated mandate (Annex 2q).

3.7 Pilot project on CLP: Child-resistant fastenings

3.7.1 WG progress report

The chair of this WG informed the meeting that the operational phase started on 15 July and will last until 31 Dec 2015. The National Coordinators raised no challenges so far.

3.7.2 Mandate amendment

The mandate of this WG was revised and the Forum adopted the updated mandate (Annex 2h).

3.8 REACH-EN-FORCE-3

3.8.1 Task Force progress report

On behalf of the Task Force, ECHA Forum Secretariat informed on the status of the project. The Task Force would assess the comments received from the Forum members on the draft report during the consultation round (13-27 October), to be finalised after the Forum-22 meeting.

3.8.2 Mandate amendment

The timeline was revised and the Forum adopted the updated mandate (Annex 2i). Once the report is published, this mandate would be automatically closed.

3.9 Information and Communication System for Market Surveillance (ICSMS)

3.9.1 WG progress report

The chair of this WG presented the status of the project that continued to follow the development of the tool by COM to assure that it covers the NEAs' needs. The ICSMS would be used to report the cases of non-compliance by the means of Product Information (PI) forms.

It was previously agreed to have one PI form per substance/product, covering the cases concerning all three legislations (REACH, CLP, possibly PIC). However, some WG members favoured the possibility to have three different PI forms in ICSMS, one for each legislation. According to COM's assessment, splitting the forms could cause several months of delay in the delivery of the tool to the NEAs. From the NEA's perspective, having the three PI forms would allow separate EAs to work in parallel on their cases and individually update and close the cases when needed.

The Forum discussed the pros and cons of the options but there were still some open questions that prevented the Forum to make a decision. Therefore, the Forum mandated the WG to liaise with the relevant actors to explore all the possible scenarios and decide which option would better serve the NEA's needs.

3.9.2 Mandate amendment

The mandate of this WG was revised according to the discussion held and the Forum adopted the updated mandate (Annex 2j).

3.10 Interlinks

3.10.1 WG progress report

The chair of this WG presented the status of the project and the Interlinks guide's content. A draft guide was provided for consultation with the Forum members.

It was requested for Forum members to liaise with their MSCA to assess whether the regular status reporting of Dossier evaluation follow-up cases via CIRCA and Portal Dashboard-NEA was necessary.

Due to the Board of Appeal decision on SONCs, the WG halted all developments of the issues concerning SONCs until a decision on how to proceed would be provided by ECHA.

The WG member leading the pilot project that followed up on specific cases of non-compliance with harmonised classification identified by ECHA informed that the operational phase was concluded and a report should be prepared for Forum-23.

3.10.2 Follow-up of ECHA Decisions: updates from ECHA

A document was submitted to the Forum with all the SONC cases that were sent to the Member States Focal point by 2 October via RIPE.

3.10.3 BoA decision on a SONC case

The chair of the Board of Appeal (BoA) presented the decision taken on 29 July on the case appealed by Solutia Europe (A-019-2013) concerning "Notified substance – Statement of non-compliance (SONC) – Procedure under Article 51 of the REACH Regulation)".

3.10.4 Mandate amendment

A new chair was appointed, the mandate of this WG was revised and the Forum adopted the updated mandate (Annex 2k).

3.11 Implementation of RIPE/PD-NEA

3.11.1 WG progress report

The chair of this WG summarised the activities between July-Nov 2015. The WG was focused on the preparation of the Portal Dashboard (PD)-NEA/ePIC workshop for single points of contact (SPOCs) planned for 26-27 January 2016. The Forum was invited to comment on the workshop's agenda. The WG was also preparing a document with the data requirements for the BPR inspectors to be included in the future PD-NEA tool.

COM's representative informed the meeting on the new "Biocides enforcement group" (BEG) that DG SANTE would manage and would possibly meet back-to-back with the Forum. Possibly the expansion of RIPE/PD-NEA would be under the remit of this group and a future collaboration between Forum and BEG was encouraged.

3.11.2 RIPE/PD-NEA project progress report

ECHA Forum Secretariat presented the progress of the RIPE/PD-NEA project. On 18 January 2016, ECHA planned to make three tools available for NEAs (PD-NEA, ePIC and Integrated Access Management (IAM) - portal for managing users, accessible to NEA Administrators only). All users and messages will be migrated from RIPE to PD-NEA. The presenter informed the meeting on the new functionalities and scope of the new tools.

There will be a workshop for user administrators (including NEA administrators) in Feb 2016. In case ECHA did not receive appointments for a certain country, ECHA would assume that the existing RIPE administrator would take over the role of NEA administrator and would migrate the account.

A Forum member regretted that the two IT systems would not be running in parallel. ECHA Forum Secretariat informed that, due to technical reasons, ECHA decided to shutdown RIPE after the migration. He added that training on the advance search of the new tool would be included in the workshop.

When questioned about the audits guidelines, ECHA Forum Secretariat clarified that the security regime applicable to PD-NEA would be the same as the one previously used for RIPE.

3.11.3 Mandate amendment

The mandate of this WG was revised and the Forum adopted the updated mandate (Annex 21).

3.12 Enforceability of restrictions

3.12.1 WG progress report - Advice on restrictions

The Chair informed that the document submitted for this agenda item included information on the issues related to the advice on restrictions.

ECHA Forum Secretariat informed that the restriction process, namely the Forum Guide on Enforcement for dossier submitters, would be consulted with the CARACAL in November. COM and ECHA would jointly organise a workshop on restriction proposals for Annex XV dossiers (Brussels, 19-20 January 2016). It was encouraged for members of the WG to participate in the workshop to support the discussion.

The chair of the WG recommended for himself and the expert that was more involved in the elaboration of the guide to participate in the workshop.

The Forum agreed with the publication of the Forum Guide on Enforcement for dossier submitters, once finalised.

3.12.2 WG progress report - Analytical methods

The WG co-chair presented the status of the work of this sub-group elaborating the compendium of analytical methods to check compliance with Annex XVII restrictions. A final consultation and consequent written procedure for adoption of the compendium would be launched in order to have a final version available in January 2016 for the operational phase of REF-4.

The Forum members were requested to liaise with the laboratories to agree with the publication of specific information provided, by means of a letter to be created by ECHA Forum Secretariat/WG.

The WG proposed to have a public consultation of the compendium during 2016, with the possibility for the users to provide feedback to be assessed by the WG during the revision of the compendium in 2017. The Forum agreed to revise the methodology for recommending analytical methods as suggested.

The co-chair added that the WG was aware that some developments on the standards were being done at EU level and further developments by national bodies would be welcomed to complement the Forum's compendium in the future.

3.12.3 Update on the Annex XVII better understanding project

ECHA Secretariat presented the status of the project on Annex XVII (restriction entries) coordinated by ECHA in cooperation with Commission.One of the tasks was to develop public Q&As on the Annex XVII entries. The presenter provided some background information on the actions taken and the deliverables available. The previously non-public Q&As were to be re-assessed and made publicly available in the future.

A Forum member remarked that the issues compiled in the FAQs/Q&A under the umbrella of the project should eventually be reflected in the legislation.

In the context of REF-4, ECHA Secretariat would make a screening of Annex VI and provide links to the available Q&As. The guideline for the nickel restriction was expected to be endorsed by CARACAL during the first half of 2016.

A Forum member appreciated the project and its deliverables since it was noted that industry might not be fully aware of the interpretation used by the inspectors.

Another Forum member informed that more clarification on the interpretation of entry 59 (paint strippers) could be provided.

An invited expert appreciated the establishment of a link between the entries and the correlation table between REACH entries and CN/TARIC codes used by the customs authorities (under preparation by DG TAXUD).

3.12.4 Mandate amendment

The mandate of this WG was revised and the Forum adopted the updated mandate (Annex 2m).

Item 4 - Conclusions from day 1

The Forum adopted the conclusions and actions points collected for the issues discussed during the day.

Item 5 – Debriefing of the meeting with ECHA Directors

The Chair summarised the discussions held with ECHA's directors.

The Chair invited the members to provide written comments on the issues.

Item 6- Updates from the ECHA Secretariat 6.1 ECHA tools to support control of extended SDS

The ECHA Secretariat representative informed the Forum on the tools available to industry to improve the supply chain communication. The <u>CSR/Exposure Scenarios</u> (ES) roadmap and Exchange Network on Exposure Scenarios (ENES) were created to set out the proper initiatives to overcome such challenges for the supply chain communication. Some of the work focused on format harmonisation of the ES, facilitating its electronic transmission (with catalogue of standard phrases), streamline the content and make it easier for readers to navigate between the SDS and ES. Support for the recipient of the extended SDS (guides and SDS checklist) was also available.

To improve the communication of mixtures in the supply chain, the sector organisations have been developing two methods, based on the safe use of mixture information (SUMI)-bottom up approach- and Lead Component IDentification (LCID)- top down approach.

The Chair referred that the REF-5 project would be able to provide valuable feedback on the available tools and welcomed a future breakout group to discuss how enforcers could support the implementation of CSR/ES roadmap.

6.2 SVHC Roadmap implementation activities

The ECHA Secretariat representative informed the meeting on the ongoing activities related to the implementation of the SVHC roadmap, namely on Public Activities Coordination Tool (PACT). This tool was a table published in ECHA's website that informs on cases where ECHA and evaluating authorities had selected a substance for informal assessment of the hazard properties or have the intention to analyse its risk management options. The PACT was used for industry as a planning tool; however, notifying a substance to the PACT remained a voluntary action from the authorities and it did not necessarily indicate that such substances were facing regulatory actions.

The Chair stated that the information in the table might generate some expectations by the public, which, as a consequence, may also influence the enforcement actions.

6.3 Guidance updates

The Forum took note of the updates from ECHA Guidance.

6.4 Integration of REACH information into environmental, health and safety practices

The Chair summarised the document submitted for the meeting with information of the follow-up actions after the workshop held in ECHA in April 2015 on how information generated through the REACH and CLP processes can be used to promote the safe use of chemicals at industrial sites.

6.5 Recent BoA ruling on SONC

ECHA Secretariat representative presented the potential implications of the BoA decision on SONCs on the follow-up processes, as continuation of the item addressed at 3.10.3. ECHA shared with the Forum the document submitted to CARACAL about the implications of the recent decision A-019-2013 of the BoA relating to the appeal of a SONC . The paper outlined the draft ECHA position on how the BoA decision could change the follow up of the dossier evaluation process.

Item 7 - Update on relevant developments by the Commission

7.1 General updates by the European Commission

The Commission representative informed the meeting of the issues discussed at the COM level that may influence the work of the Forum.

He informed the Forum on the relevant discussions that would take place in CARACAL and the ESPG meetings (e.g. definition of "placing on the market" (CLP), the simplification of the authorisation process and the halting of Annex XIV to allow inclusion of new substances).

After the experiences with REF-4 regarding the financial possibilities, he informed that COM has somewhat regular opportunities that the Member States could benefit from (e.g. related to Market Surveillance regulation or exchange of inspectors (LIFE+)). Other programmes could be generated for a specific project/study and he advised the Forum members to investigate all available

opportunities for future needs/projects. He warned that the administrative procedures for application to such budget requests were cumbersome. A Forum member mentioned the future pilot project on substances in articles that could benefit from this funding.

He informed that the competent authorities for Biocides were in favour of integrating the enforcement of Biocidal Product Regulation (BPR) under the Forum's remit. DG SANTE proposed for the transition of the responsibility on Biocide enforcement to the Forum to be made gradually by creating a working group of Biocides CAs (Biocides enforcement group –BEG). The group would meet back-to-back with the Forum meetings so that Forum members dealing with the BPR could also participate in the BEG's discussions.

Some Forum members questioned the need to create such group since the Forum and CAs already expressed the preference to include BPR as one of the Forum's responsibilities. COM representative clarified that DG SANTE was in line with the preference mentioned but that some budgetary considerations were also taken into account. Therefore, the BEG was created as an intermediate step until the financial resources were available for the Forum to take over the task (in 2-3 years). ECHA Forum Secretariat added that the BPR task for the Forum would need to encompass also extra resources for ECHA and a note from the Commission clarifying the legal basis for the Forum's mandate for dealing with BPR.

He highlighted a news item released by COM stating that it would support all Member States in creating a compliance culture for single market rules (single market strategy).

He informed on the topics related to the Market Surveillance Regulation that relate to some of the Forum's works, for instance that RAPEX system would be integrated in ICSMS in the future. A Forum member suggested for some members of the Forum ICSMS WG to be involved in such discussions. COM representative volunteered to share the agendas of the meetings with the Forum.

Upon a question from a Forum member, COM representative clarified that under the general product safety directive, DG JUST might request from the Member States more information on REACH, depending on their information needs.

7.2 EU level enforcement indicators

The Commission representative informed the meeting on the preliminary results of the enforcement indicators at EU level. For the calculations it used the data collected from the Member States reporting, from ECHA and COM.

Some Forum members expressed concerns on the possible misinterpretation of some values without the proper background information and the potential ambiguity of some terms (e.g. "controls", "degree of compliance") and questioned the usefulness of the indicators.

COM representative invited the Forum to engage on setting definitions for the unclear terminology. The data collected for some calculations were the ones done via the appropriate procedures (e.g. number of official complaints). He reassured that the final report would include caveats and information for the reader to understand the results presented.

7.3 Forum level enforcement indicators

ECHA Forum Secretariat presented the preliminary results for the Forum level indicators. The Forum members were invited to comment on the usefulness of

these indicators and how they could be used to better plan the work of the Forum.

A Forum member suggested not to calculate the indicators for which no data was available instead of making assumptions. In addition, the Forum should strive to create its own indicators based on the needs of the Forum.

Item 8 - Enforcement projects in Member States

8.1 Use of bridging principle in detergents – challenges of enforcement

A Forum member presented the intermediate result of a project held in its Member State concerning the investigation of household (laundry and dishwasher) detergents by checking compliance of some particular issues according to the detergent regulation, CLP and REACH. The inspectors observed that the detergent industry widely use bridging principles to classify mixtures, namely the principle of "substantially similar mixtures" (CLP annex 1 section 1.1.3.5).

Further investigation of the classification dossiers by the NEA's chemical experts were still needed as well as a reply from the national Helpdesk.

Item 9 – Cooperation with other networks 9.1 Summary of the last CLEEN meeting

ECHA Secretariat shared with the Forum the issues that were covered in the last CLEEN meeting that took place on 1 and 2 October, in Stockholm, which might be of interest to the Forum.

The Forum agreed for a Forum member to be mandated to represent the Forum in the SLIC-CHEMEX working group, depending on the availability of resources.

Item 10 - Preparation for the open session

The abstracts of the topics brought by ECHA's accredited stakeholder organisations (ASOs) were analysed and a common approach was agreed.

Item 11 - Conclusions from day 2

The Forum adopted the conclusions and actions points collected for the issues discussed during the day.

Item 12 - Welcome and Introduction to the OPEN SESSION

The Chair welcomed the participants, ECHA accredited stakeholders (ASOs) and observers (representatives of the Instrument for Pre-Accession Assistance programme). She informed the meeting that the session was available via webstream to all ASOs that registered to follow the session remotely.

The presentations of the open session would be made available on ECHA's website¹.

Item 13 – Welcome by ECHA's Head of Unit Support, Forum & HelpNet Secretariat

The Head of unit of ECHA's Support, Forum & HelpNet Secretariat unit welcomed the participants and summarised some of the issues to be addressed by the ASOs and Forum members during the open session. He highlighted that the Forum and ECHA Secretariat value the interactions with stakeholders and that in the past year Forum dedicated substantial effort to discuss and agree on a number of actions to further improve the cooperation with the ASOs. He also stressed the increasing number of Forum's projects and encouraged the participants to have open and fruitful discussions.

Item 14 – Discussion topics

14.1 Liquid Laundry Detergent Capsules

14.1.1 State of play on implementation of Regulation (EU) No 1297/2014 and voluntary industry initiatives

The A.I.S.E representative informed that a significant number of accidental exposures involving liquid detergent capsules, in particular in young children was reported to poison centres. Consequently, the CLP regulation was amended (annex II). This Regulation prescribed a number of technical packaging measures for the outer packaging and the soluble packaging of these products, applicable as of 1 June 2015. The A.I.S.E representative presented the sector implementation guidelines, developed by the association, to facilitate compliance with the CLP Regulation by its members.

In addition, some campaigns have been launched by this association to educate consumers and promote safe use. The presenter informed that all the material for the campaigns were available in all EU languages.

A report on Accidentology, with the participation of poison control centres, will be available in November 2015.

14.1.2 Forum's feedback

The Chair informed that the Forum had considered to include the liquid detergent capsules in the scope of its pilot project on child resistance fastenings. The running project investigated the provisions of CLP article 35 (2) before the amendment. Due to the nature of a pilot project and its short timeline, the Forum decided to exclude the detergents capsules from the scope of this particular project. She also proposed further investigation of the distributers/retailers and raise their awareness on the regulation to avoid placing on the market noncompliant products.

Other Forum members shared their national projects investigating these products. Two Forum members presented comments to the association's Guidelines on Liquid Laundry Detergent Capsules (27 February 2015).

COM highlighted to the participants that when public finds a non-compliance case, the first contact should be the NEA.

14.2 REACH information requirements

14.2.1 Enforceability of REACH information requirements

The ClientEarth representative introduced its non-profit organisation and presented some of its findings on compliance checks by investigation available reports from COM, ECHA, Forum and other national studies. The NGO observed

that few sanctions were being applied and there was no evidence that the market had been restricted for non-compliant substances.

Therefore, since enforcement had the goal to ensure the registration objectives, he encouraged more intervention from enforcement authorities by applying sanctions or withdrawing the substance from the market. That would create an incentive to companies to increase the safety of the use of their substance and to document it appropriately in their registration dossiers. The NGO representative stressed that for cases for which a SONC had been issued, enforcement authorities should react and somehow penalise the company for its noncompliance.

The Chair replied that the Forum projects were based on risk reduction measures and the inspectors would firstly try to remedy the situation with administrative orders and bring the company to compliance. It should be noted that national legislations should be taken into account when applying sanctions and many foresee the first approach to be administrative measures.

She informed that ECHA and Forum were discussing the implications of the BoA ruling concerning the SONCs that would have potentially more impact in ECHA's evaluation process rather than on the enforcement aspect of the decision. She added that NEAs have also the possibility to signal to ECHA cases for compliance check.

ECHA Forum Secretariat added that ECHA reported low compliance rate from the dossier evaluation process because such evaluations were done for specifically targeted deficient/incomplete dossiers.

14.2.2 German experiences with SONC cases

The German Forum member explained that upon receiving the SONC via the Focal point, it was forwarded to the appropriate federal state's authority. The registrant was contacted to update its dossier with the requested information. Once the update was done, the registrant should inform the NEAs of that fact. It was a crucial step since only upon the NEA's request, ECHA would re-assess the dossier and the new information provided. The member recommended that the ASOs inform their members to always contact the NEAs once a SONC is received instead of spontaneously updating the dossier.

14.3 Responsibilities of the different actors in the supply chain

14.3.1 Responsibilities under REACH enforcement – A case study

The representative of the European Association of Chemical Distributors (FECC) presented a case from one of its members regarding the responsibilities of the different actors in the supply chain. In the case in question, the identified company (company D) was the supplier, as it sold the substance to Downstream Users. The obligation to provide a complete Safety Data Sheet (SDS), according to Article 31, rested on the supplier. While clearly company D made efforts to obtain the exposure scenario (ES) from its supplier (company M), company D remained responsible for providing a complete SDS to its own clients down the supply chain. The company who was fined (company D) believed that they were not in breach and requested clarification from other industry organisations and ECHA helpdesk. The presenter welcomed the Forum's views on the case.

14.3.2 Forum's feedback

The Chair highlighted that the Forum usually did not discuss particular cases. According to the description of the case, company D seemed non-compliant with the obligation to supply an SDS containing ES.

The Forum agreed that the enforcement authority had grounds to apply enforcement measures. However, these depend on national legislation and therefore the Forum could not comment on this aspect of the case.

A stakeholder representative raised concern that a common position from the industry associations, agreed in the past, was not in fact in line with the enforcement actions. The Chair replied that the enforcers follow e the legislation and ECHA Guidance. Industry consults ECHA and, when relevant, the Forum, on their guides and the responsibility of the final text remains with the author. ECHA Guidance could also be challenged during its public consultations, Partner Expert Group consultation (often members of industry were part of these groups) or by filling a web-form. The presenter added that the industry association was not fully confident of the statements provided to the company in the case presented.

Another stakeholder mentioned the fact that COM could also strive to clarify the legislation and avoid different interpretations.

14.4 Intermediate uses

14.4.1 Towards a consistent interpretation of complex cases of intermediate uses between registrants, downstream users, and enforcement authorities

The representative of Eurometaux raised awareness of the importance to clearly explain intermediate and non-intermediate uses. With the enforcement of REACH, manufacturers, importers and downstream users faced inspections by national authorities and identified the need to further discuss and re-qualify intermediate uses, in particular for the most complex processes/cases commonly occurring in the inorganics/metals sector.

The organisation had a project in place to share technical knowledge and to translate it in to regulatory requirements with the objective to create guides that could be used by industry, COM, ECHA, Members States and its enforcement authorities. CARACAL was also involved to take decisions on borderline interpretations. The Forum and Member States were invited to participate in the project and share some specific cases of complex uses involving metals.

14.4.2 Forum's feedback

The Chair informed that the Forum had completed a pilot project on intermediates and encouraged the organisation to liaise with the competent authorities who could then involve their enforcement authorities.

A Forum member informed that its country conducted a project on intermediates where no problems were found with the intermediate status but with the DU declarations and the use of strictly controlled conditions.

Another Forum member stated that the Forum would start its second pilot project on Authorisation, investigating the substances with the sunset date on 2016, which would also take into account the exemption for the intermediate use.

Item 15 – Enforcement projects in Member States 15.1 National database of substance SDS models

The Italian Forum member presented a national initiative to prepare a collection of models of SDS of substances intended to be used by those compiling SDS and by the National Enforcement Authorities. The objective was to make available models of SDS of substances compiled in accordance with the requirements of Article 31 of REACH and Annex II of REACH and to facilitate the compilation of

SDS consistent and complete both from a formal as well as from a substantive point of view. The models were made public and updated regularly.

15.2 Raising awareness of citizens: national strategy and involvement of schools

The Italian alternate presented another Italian project focusing on educating the public as a strategy for the enforcement of REACH and CLP. From elementary until post-university, students were targeted for this campaign, by informing about the public's right to know (Article 33.2), safe use and exposure to chemicals, CLP labelling, how to access the proper information of the substances and the chemical regulations and its regulatory activities. Educational tools were created and the students/teachers were encouraged to participate in the project by means of different activities and competitions on the subject. The project proved to be very successful and it will continue. A new e-learning tool was being developed to facilitate the dissemination of REACH/CLP tutors' training.

15.3 Danish enforcement project "REACH article 33" duty to inform (SVHC in articles)

The Danish invited expert presented a project targeting the obligation for companies that market articles containing Candidate List substances in a concentration above 0.1 % (weight by weight) to inform a consumer about the content if asked (as a minimum the name of the substance(s)). The campaign was targeted at consumers to inform them about their right to request such information and a website, a database and a mobile app were created for this. The bar code of a group of 50 products should be entered/scanned and would automatically send a request to the company owning the bar code to provide information on the product. The industry was involved in the preparation of the project and the contacted companies were aware that the Danish authority originated the request.

The tool created could be used to explore other areas by the Danish authorities for the future applications (e.g. for allergens).

A stakeholder representative suggested involving the supplier in the project in order to assess the flow of the information in the supply chain. The presenter clarified that from the IT-design point of view, it was decided to send the request to the bar code owner, which were not necessarily the manufacturers.

15.4 Sweden's experiences from enforcement of REACH and other regulations for articles

The Swedish Forum member presented the inspections focused on specific articles. The inspector assessed all the relevant regulations that the consumer article must comply (e.g. an electric toy car should comply with the toy safety directive, REACH, Directive on packaging and packaging waste, battery directive). He shared the experiences gathered and informed that a new report for 2014-2015 was under preparation.

Item 16 - Updates from Forum

16.1 Update of the Stakeholders' proposals for the scope of REF projects

The chair of the WG Prioritisation of REF projects informed the meeting on the proposals submitted by the stakeholders that where assessed by the WG and were considered during the prioritisation process of REF-5 on Extended SDS and RMM as well as for the recommended two pilot projects (on CLP Article 48 and substances in articles). It also included the reassessment of proposals submitted in previous years for which all the mandatory criteria were fulfilled.

He invited the Stakeholders to submit new proposals by April 2016 to be assessed for the next REF prioritisation.

16.2 State of play with the Compendium of Analytical methods

The co-chair of the WG Enforceability of restrictions presented the status of the compendium of analytical methods to be recommended by the Forum to industry and enforcement authorities. The compendium was in the final stages where for 41 restriction entries, 148 methods were recommended. The publication was foreseen for the end of 2015/Q1 2016 in ECHA's webpage. The Stakeholders were invited to disseminate this information to their members and networks and to submit feedback during 2016 to be considered during the Compendium's update.

She added that CEN (European Commission for Standardization) had to be yearly mandated by COM to develop a standard, which was regulated by a specific framework. Some issues regarding annex XVII have been included in their work plan for 2015.

16.3 Improving cooperation with ASOs: Update and follow-up actions

ECHA Forum Secretariat provided a room document reflecting the improvement actions collected from the last open session where a brainstorming session was held with a view to find ways to further improve the cooperation of the Forum and ASOs. The Forum discussed those ideas during 2015 and some actions were taken on board.

16.4 REF-3 project report: an overview

A member of the WG managing the project REF-3 presented the preliminary results of the project that ran in two operational phases in 2013-2014. The project investigated the compliance with registration obligations by manufacturers, importers and only representatives in close cooperation with customs. The second phase of the project focused on ORs and a number of cases were investigated to assess the communication flow in the supply chain.

The ASOs were alerted that importers/importing DU and ORs were the groups more at risk of being non-compliant as well as SMEs. The report would be published in December 2015.

The presenter clarified that for her Member State, the inspectors received the data from customs authorities referring to all substances imported for a calendar year. On the other hand, in other countries, the customs authorities made the risk assessment of all the substances imported and provided the selected data to the REACH inspectors.

Item 17 - Enforcement indicators by COM

17.1 Does enforcement work? Enforcement indicators at EU level

The Commission representative informed the meeting on the preliminary results of the enforcement indicators at EU level. For the calculations the data used was collected from the Member States reporting, from ECHA (including Forum) and COM. The results of those indicators would be used in the next REACH review.

The presenter clarified that the methodology for calculation some of the indicators (e.g. penalties vs compliance costs) was still under discussion.

A stakeholder signalled that quantitative indicators might not provide the most correct depiction of the real scenario since many qualitative factors were not taken into account.

Item 18 - Conclusions and end of the open session

Some participants took the opportunity to express some recommendations to the Forum. A Stakeholder urged the enforcement authorities to apply all corrective actions at their disposal as a way to compel companies to be compliant with REACH.

Another stakeholder suggested for the Forum to follow-up a project from EuroDeter where many non-compliances were found. She proposed a ranking system for severity (e.g. from the health and environment perspective) as a way to prioritise the inspections.

Another Stakeholder considered it interesting to collect information over time to assess if a trend could be established and if the situation on specific issues improved.

The Chair welcomed the feedback and thanked the Stakeholder and observers for their participation. With that, she closed the open session.

Item 19 – Debriefing of the open session

The Forum members expressed appreciation for the discussions held during the open session. They stated the number of ASOs present remained low and discussed how it could be increased. Some suggested to develop the agenda in a way that particular stakeholders, dealing with a particular issue, could be specifically invited.

Item 20 - Practical issues for enforcement of REACH and CLP

Issue 1 - How MSs handle individual registrations for chemicals for which a SIEF exists.

ECHA Forum Secretariat informed that a previous conclusion for this issue was adopted in written procedure by consensus. However, the discussion during the WG Interlinks meeting on 14 October 2015 created the need to make small changes in the basis for the conclusion. The change was necessary to make it consistent with WG Interlinks advice for NEAs to forward their suggestions for compliance check to ECHA through their MSCA rather than address the ECHA Focal Point, since MSCA had already a mechanism and template to be used for requesting ECHA for a dossier compliance check.

The Forum agreed with the change and adopted the conclusion.

Item 21 - Updates from the ECHA Forum Secretariat

21.1 Preparation of the revision of the Forum MAWP

ECHA Forum Secretariat informed that the revision of the Forum's Multi Annual Work Programme (MAWP) was scheduled for 2016. The main revisions ware related to the update of the details of the projects (timelines and mandates).

It was proposed for ECHA Forum Secretariat to revise the MAWP in consultation with the Chairs and afterwards to consult the Forum, thus removing the need for a WG. In addition, COM requested their agencies to prepare a "Single Programming Document" to replace the existing work programme, aggregating all high level plans but in a more succinct way. ECHA was preparing for this transition which would include information of the Forum's activities. However, since the Forum's MAWP was an important document with detailed information to help drive the Forum's work, it was proposed to keep it and add more detailed information in order to make it as an activity plan.

The Forum agreed to move to the activity plan-structure during the proposed revision process.

21.2 Organising the revision of Forum's Best Practice documents

ECHA Forum Secretariat informed the Forum that the "Strategies for enforcement" and "Minimum criteria" documents were last adopted in 2011 and that the MAWP foresaw a revision during 2015-2017. The number of projects running during 2016 and 2017 was presented to help the Forum decide on the appropriate timing to initiate the task.

The Chair stressed that it would be challenging to allocate resources for this WG and proposed to rely more on web and phone conferences. The Forum agreed to have a breakout group during 2016 to assess the extension of the revision needed and decide on the appropriate way to tackle the task.

21.3 Content of the Guide for inspectors based in REF experiences

The Chair informed that this topic was already addressed in item <u>3.2.1</u> by the chair of WG Prioritisation when revising the methodology.

Item 22 - A.O.B.

22.1 Change of dates of Forum-23

The Chair proposed to change the dates of the Forum-23 meeting due to conflicting schedules. The Forum agreed to keep the dates as previously planned (third week of March 2016) but start the meeting on Wed 16 March and finalise on Fri 18 March at lunchtime. The preparatory meeting would take place on Mon 14 March.

22.2 ECHA's Guide on Reimbursement - adopted at MB meeting

ECHA's Forum Secretariat informed the meeting that it was decided by ECHA's Management Board (September 2015) that the Forum members and one invited expert would continue being reimbursed, with the change that the daily allowance would be given referring only to the days of the meeting, excluding the travel time (flat rate). If no flights were available and there was a need to arrive the day before or depart the next day, 50% and 25% of the daily allowance would be provided for those extra days, respectively. The new amended guide of reimbursement would be effective as of 1 January 2016.

Item 23 - Conclusions from day 3 and 4

The Forum adopted the conclusions and actions points collected for the issues discussed during these days.

Item 24 - Closing of the meeting

The Chair thanked the participants, the COM and the ECHA Forum Secretariat for their contributions and support. With that, she closed the meeting.
