I. Summary record of the proceedings

Item 1 - Welcome and introduction

1.1 Welcome and opening by the Forum Chair

The Forum Chair welcomed all the participants and opened the meeting. She announced the attendance of 26 Forum members from EU Member States with voting rights and the three EEA countries. Romania was not represented and provided the proxy to Sweden. The Chair informed that the quorum requirement was met.

1.2 Adoption of the agenda

The Chair indicated the changes in the agenda. The agenda was adopted (Content II, Annex 1).

1.3 Declarations of conflicts of interest with regard to agenda items

No conflicts of interest were declared at the meeting according to Article 9(2) of the Rules of Procedure.

Chair informed that the annual collection of declarations of interest of Forum members was launched and that an automated email including a personal link was sent. Forum members were encouraged to submit their declarations by the deadline.

1.4 State of play with action points from Forum-42

Forum members took note of the status of the action points from Forum-42 as listed in the meeting document.

1.5 Results of the written procedures and other issues between Forum-42 and Forum-43

The Chair referred to the document with the results of the written procedures between Forum-42 and Forum-43.

Item 2 - Forum's enforcement activities - Ongoing projects

2.1 Prioritisation of REF projects

2.1.1 Discussion of the proposals for the next pilot project

The WG chair presented the outcome of the prioritisation of the proposals for Forum small-scale pilot projects received by the WG.

The Forum concluded that the next Forum pilot project will focus on the enforcement of perfluorocarboxylic acids (PFCAs) and related substances focusing on cosmetics.

The WG chair informed that the deadline to submit the proposals for REF-13 and BEF-3 projects by Forum/BPRs members, COM, ECHA and ASOs was mid-April 2023.

2.1.2 Mandate amendment

The Forum adopted the updated WG mandate (Annex 2a).

2.2 REF-12 on the compliance of imported substances, mixtures and articles

2.2.1 Agreement on the scope of the project

The Forum took note of the work done by the WG that has started to prepare the project manual. The project will investigate the REACH obligations concerning Registration, Authorisation and Restriction, to be checked in collaboration with Customs.

The WG was exploring the possibility to include in the project's scope the new TARIC codes for REACH Annex XVII that were introduced in February and which were found challenging to implement in practice.

The WG was prioritising the substances/mixtures/articles to be targeted for inspections by performing risk profiles. The Forum members showed interest in assessing an example of a risk profile to better understand how the dialogue with the customs authorities could be pursued nationally. Moreover, the Forum was concerned about the workload that such profiling could originate for the WG members.

The Forum agreed with the plan of the WG to continue building the risk profile, with attention to the resources spent on this particular task. The Forum would be able to analyse and comment on it during the consultation of the draft manual during the summer.

2.2.2 A game change for improved import controls? REACH Annex XVII restrictions introduced in TARIC on 10.2.2023

A Forum member presented the issue that was originated with the publication of the new TARIC measures regarding REACH restricted substances, in particular the new Y conformity declaration codes that needed to be consistent with REACH. Moreover, these new measures were considered only informative and should be more precise and product-related. For that reason, the Member States/NEAs had to perform their own interpretation and it would be more efficient if there was a harmonised methodology for its implementation in the whole EU. In the meantime, it was proposed for NEAs to contact their customs authorities and discuss the best way forward.

The Forum agreed to mandate the WG REF-12 to analyse this issue by liaising with COM/DG TAXUD in order to clarify the applicability of the codes. The Forum requested support from DG TAXUD to work with REF-12. The WG would consider including it in the scope of the project and present the status of this task to the next Forum meeting.

2.2.3 Mandate amendment

The Forum adopted the updated mandate (Annex 2b). The WG requested additional customs experts to be nominated to be part of this WG.

2.3 Enforceability of Restrictions

2.3.1 WG progress report

The Forum took note of the work done by the experts in the WG and its advices.

2.3.2 Mandate amendment

The Forum adopted the updated mandate (Annex 2c).

2.4 REF-9 on Authorisation

2.4.1 WG Progress report

The WG chair informed that the project report was adopted on 13 February 2023 and published on ECHA website on 8 March 2023 together with the news release and podcast. The practical guide on enforcement of REACH authorisation obligations was under preparation by the WG.

The Workshop with ECHA Accredited Stakeholder Organisations (ASOs) and industry on the REF-9 project results and recommendations would take place remotely on 12 May 2023. ECHA ASOs, representatives of the industry, COM representatives,

ECHA experts, Forum members, REF-9 National Coordinators, NEAs representatives and RAC and SEAC members would be invited for this event.

2.4.2 Mandate amendment

The Forum adopted the updated mandate (Annex 2d).

2.5 Pilot project on classification of mixtures focusing on detergents and cleaning products

The WG Chair updated the Forum with the progress made by the WG.

The Forum members were invited to nominate experts to continue the analysis on the concerned national cases on mixture classification.

2.5.2 Mandate amendment

The Forum adopted the updated mandate (Annex 2e).

2.6 Projects not for discussion and with no progress report

The Forum addressed and confirmed the mandates of the WGs that were not discussed at the meeting:

- 2.6.1 REF-10 on Integrated control of products: The mandate was amended (Annex 2f).
- 2.6.2 REF-11 on SDS: Mandate amendment (Annex 2q).
- 2.6.3 Train the enforcement trainers 2023: The Training 2023 event will take place on 22-23 November 2023 in ECHA premises. The Forum members were invited to nominate two participants per Member State. The mandate was amended (Annex 2h).

Item 3 - Forum's new projects and tasks

3.1 Forum's next multiannual work programme

The current Forum Work Programme 2019-2023 will expire at the end of 2023 and a new work programme needs to be prepared to present and describe the work of the Forum in sufficient detail. The Chairs considered that in "ECHA Programming Document" the Forum outputs were covered for years 2023 and 2024, but the Forum chapter was very concise and does not provide details on the planned actions. Additionally, there should be also an alignment of the Forum's work with relevant sections of the EUPCN work programme.

The Forum agreed to draft a short and concise document, jointly with HET, proposing the Forum's multiannual enforcement priorities and outlining the main deliverables for the next years with the suggested timeline. Moreover, it could be reviewed annually to better reflect the work being developed and the decisions made by the Forum.

The first draft of the new work programme will be presented at Forum-44 and then consulted with the Forum. Members were encouraged to volunteer to participate in the informal drafting group working on the first draft of the ECHA Work Programme.

HET informed about the timeline for the preparation of ECHA's new programming document 2024-2027.

ECHA Management Board was also working on a new strategic document and Forum members might be approached by their Management Board member to provide input for this exercise.

3.2 Next Forum pilot project: Mandate set-up

The Forum set-up and adopted the mandate for the WG managing the 'Pilot project on enforcement of PFCA and related substances focusing on cosmetics' (Annex 2i).

Item 4 - Forum's enforcement activities - Projects under finalisation

4.1 Member State reporting

4.1.1 WG final report

The Forum took note of the final tasks of the WG, where the Forum adopted via written procedure the recommendation on counting methods. The Member States were invited to implement such recommendations in the coming years.

Replying to a Forum member, the Chair highlighted that in the context of EUPCN, whenever the issue on ICSMS is discussed, the position of the Forum Chairs would be to avoid double reporting.

4.1.2 Mandate closure

The mandate of the WG was closed (Annex 2j).

4.2 Train the enforcement trainers 2022

4.2.1 Final report

The WG prepared and delivered the training in ECHA premises on 24-25 November2022 on the topic of enforcement of the Safety Data Sheet. The WG Chair presented the summary of the training, which 100% of the core participants rated as "good" or "excellent". The WG also outlined some recommendations for future trainings.

The Forum adopted the WG report.

4.2.2 Mandate closure

The Forum adopted the updated mandate and closed the WG (Annex 2k).

Item 6 - Potential cooperation between OLAF, Forum and NEAs

A representative from the European Anti-Fraud Office (OLAF) presented in detail the "step-by-step" approach of their processes and the way they cooperated with Member States.

The Forum members welcomed the presentation and shared their questions and views. The Forum invited OLAF to report on the progress with defining their role under REACH and to discuss any other aspects of cooperation in one of the future Forum meetings.

Item 7 - Update on relevant developments by the Commission

7.1 REACH and CLP revision: Quick overview

DG GROW gave an update on the timeline of REACH and CLP revisions and their current content.

The presenter replied to some of the Forum members' questions and clarified that there was an intent to cover online sales in the REACH revision in conjunction with CLP and the Digital Services Act, the latter already in force and describing the set-up of marketplaces and its interfaces.

Following a question from a Forum member on the Forum's list of priorities for the REACH Review that was sent to COM in 2021, the COM representative will seek out

the possibility to provide the Forum a status of how far the Forum's comments were taken into consideration for the revision.

COM would also reply in writing whether the annual exchange of inspectors funded by COM would still continue after the hiatus caused by the pandemic.

7.2 Basic Regulation: Follow-up on the survey on the functioning of the Forum

The Forum took note of the feedback received from members on the functioning of the Forum that was collected by COM for the purpose of drafting the Basic Regulation and the next steps. In general, the replies suggested that the Forum is effective and the main challenge is the resourcing.

COM would consider the changes in CLP and REACH in order to assess the needed resources and will then mirror them in the Basic Regulation, hence the timeline for the finalisation of the Basic Regulation will be after the REACH/CLP revision.

7.3 Online sales new provisions under CLP

The Forum took note on the changes planned for CLP regarding the distance sales offers and advertisement. Obligations for online marketplaces were described in the Digital Services Act provisions.

Item 8 - Enforcement in the Member States

8.1 The new restriction of diisocyanates (#74/Annex XVII/REACH): Austrian NEAs support for implementation and their actions 2023 addressing duty holders' compliance

The Austrian Forum member presented national experiences with implementation of enforcement of the new restriction of diisocyanates. This NEA was developing a national REACH training for checking compliance with that restriction and will prepare for that a questionnaire, which can be translated and shared with the Forum.

Upon questions from the participants, the presenter clarified that there was contact with the OSH authority and with SLIC-CHEMEX. Most likely the timeline of a project on disocyanates being developed by SLIC-CHEMEX will not align with the Austrian initiative.

8.2 National Authorities – implementation and enforcement of REACH and CLP in Bulgaria

The Forum took note of the organisation of enforcement in Bulgaria and the challenges faced by the national authorities.

8.3 Experiences with controls of REACH registration of ozone from generating devices

The Forum member from Bulgaria reported on the findings about the Ozone generating devices in Bulgaria, following Eurozone's presentation in the last Forum open session.

Forum members were encouraged to continue investigating this issue and to present potential results to the Forum in future Forum meetings.

8.4 Nordic Exposure Group report on minimum requirements for exposure scenarios

The Forum noted the information about a Nordic project on the identification and assessment of exposure scenario minimum requirements.

Item 9 - Cooperation with other networks

9.1 Forum's contribution to the Product Compliance Network (EUPCN) and the ADCO Chairs' meetings

The Forum took note of the information from the EUPCN and ADCO Chairs' meetings as well as meetings of the EUPCN Partner Group on ICSMS that were attended by the Chairs and referred to in the meeting document.

9.2 Updates from SLIC-CHEMEX

The Forum took note of the information provided by the SLIC-CHEMEX Working Group via the meeting document.

Item 11 - Updates from the ECHA Secretariat

11.1 Activities of the Regulatory Support team

The team leader of ECHA's Regulatory support team (REST), previously known as "Helpdesk", gave an overview of the current activities the team supported and main topics industry request support to ECHA and national Helpdesks.

The Forum Chair welcomed the continuous cooperation between REST and the Forum in the yearly training for trainers events and other areas. In the same light, agendas of future Helpnet meetings could be shared with the Forum and if interested, Forum members can join the Helpnet meetings. Moreover, the Forum was interested in being informed about any enforcement related questions raised by the Instrument for Pre-Accession Assistance (IPA) countries.

It was important for inspectors to document the cases and for that ECHA's FAQ were commonly used as a source of information. New FAQ website has made access and search much more accessible but the display of the FAQs was found lacking as it was difficult to retrieve text except via screen-shots. Additionally, it was challenging to retrieve archived materials, such as guidance. The Forum would be informed on those issues via HET.

11.2 Update on Interact portal

The ECHA presenter highlighted the expected features of Interact portal in the upcoming releases, the open feedback form available to all Interact users to make suggestions for improvement and invited the Forum members to participate in the informal group of Interact User group, to discuss the tool's functionalities and the feedback received.

ECHA would explore adding the possibility of downloading a document from a closed collaboration. Moreover, the Forum Chair suggested collecting statistics on the use/download of Forum documents in Interact to assess its usage.

11.3 Importance of enforcement of Dossier Evaluation decisions

The Team leader of the DEV follow-up team highlighted the importance and impact of the enforcement of evaluation decisions by Member States' authorities and presented some successful examples.

He indicated that, by default, ECHA does not communicate with the registrants once the decision has been issued and re-assesses its dossier once an update is received. When it concerns the enforcement of the decision, it is in the remit of NEAs, who could contact ECHA to clarify any case-related issues.

The Forum Chair noted that the Forum's document on this issue, the "Interlinks Guide" describing all the communication processes concerning exchange of information between ECHA and Member States, could benefit from a revision. Forum members were invited to indicate the challenging topics to be addressed in this targeted revision.

11.4 Follow-up of ECHA Decisions

The Forum took note on the statistics about the cases sent to the Member States Focal points until 16 February 2023.

11.5 Breach of CLH cases in registrations identified by ECHA

The ECHA presenter informed on the result of the project where ECHA identified cases on breach of duty to use harmonised classification in registration dossier.

Item 12 – Discussion on the enforcement of specific REACH restrictions entries

12.1 Commission mandate on CMRs in childcare article

The ECHA dossier manager presented the Commission mandate for ECHA to prepare an investigation report to support the preparation of a restriction proposal on the use and presence of CMR 1A or 1B in childcare articles on the basis of REACH Article 68(2). Information about the call of evidence running by 31 March 2023 was sent to Forum members.

ECHA welcomed the input of the Forum on the draft report and its opinion on the enforceability of the restriction as well as the available analytical methods.

Forum members expressed concern with the tight timeline for the report and requested ECHA Secretariat to reiterate the request to COM to extend the deadline of this mandate.

Forum Chairs and the WG Restrictions would assess how the input from the Forum could be provided and included in the investigation report.

12.2 Restriction on PFOA in fire-fighting foams

The Forum took note of a presentation regarding the enforcement experiences in Flanders on the control of PFOA in fire-fighting foams.

12.3 Experiences with the restriction of hazardous substances used in tattooing inks and permanent make up

The Dutch Forum member invited the Member States to join in an exercise to sample tattoo inks. The Dutch NEA would coordinate the sampling, perform the analysis and bare its costs. More details on the scope, logistics and timeline of this exercise will be agreed with the participating Members States.

Forum and COM welcomed the initiative and multiple Forum members expressed their interest in participating.

Additionally, COM noted that industry had raised issues with the enforcement of this restriction and was interested in following this discussion in the future and present its view. This issue was also being addressed in the Council of Europe – European Directorate for the Quality of Medicines and Health Care (EDQM).

Another Forum member shared the experience with this restriction, where documentary check was carried out on the Safety Data Sheets. The inspectors concluded that the products contained substances falling within the scope of entry 75 of REACH Annex XVII and thus were not placed on the market.

The Chair encouraged the Forum members to continue investigating this issue and present their experiences to the Forum in future meetings.

Item 13 – Administrative costs of the enforcement of REACH restrictions

A Forum member raised the concern on the current "administrative costs" of enforcement for the REACH restrictions that were considered during the preparation of Annex XV dossiers. It was clear that the default amount is, in most if not all cases, a severe underestimation of the real costs for enforcement in the Member States. It was suggested that such cost should be made more visible, *e.g.* in the recitals.

The Forum member invited COM and the dossier submitter to provide, as much as possible, robust figures which may, in the course of the restriction process, lead to a substantiated estimate of capacity and budget needed for enforcement and if possible, to reflect it in the REACH Revision.

The Forum supported these proposals and highlighted the need to raise awareness with all parties involved in the assessment of enforcement costs.

Item 14 - Enforcement in the Member States

14.1 Enforcement activities in Belgium

The Forum took note of the 2021-2022 Belgium national REACH campaigns on textiles, creosote and charcoal.

Forum members were interested in more information on the analytical methods used in the textiles project.

14.2 Results from analytical campaigns on REACH restrictions

The Forum took note of the national campaigns in Cyprus during 2021 and 2022 related to restrictions. As per request of the members, the list of laboratories used in these campaigns would be shared with the Forum.

The Forum Vice-Chair encouraged the Forum members to raise the issue of the need for EU testing facilities for CLP/REACH with their national single liaison officer (SLO), to bring it to the attention of the participants of the EUPCN meetings.

This presentation raised a topic for future discussion on the best way to target the restrictions for controls. The Forum members were invited to share the experiences on this issue as well as on the use of screening devices.

14.3 Challenges of POP Regulation enforcement

The Forum took note of the challenges found when enforcing POPs regulation in Estonia.

The Forum members were invited to provide feedback on the issues raised in the presentation.

Item 16 – Practical issues for enforcement of REACH, CLP, PIC and POPs

Forum discussed one open practical issue relevant to enforcement in break-out groups, *Issue 41.1 – Training requirements under the diisocyanates restriction.*

The comments gathered from the discussions will be processed by HET to generate the next version of the draft conclusion of this issue, which is then to be consulted with the Forum members.

Members were invited to submit new practical issues by 24 April 2023.

Item 17 – Debriefing of the meeting with ECHA Directors

The Chair informed the Forum about the discussions that took place during the meeting with the ECHA management on 15 March 2023.

Item 18 – Updates from BPR Subgroup

The BPRS Chair briefed the Forum on the issues to be discussed at the BPRS-18 plenary meeting. In particular, the BEF-2 reporting phase was kicked off in January 2023 and the deadline for submitting the data was set on 3 March. Afterwards, national coordinators will be invited to validate their national data. The WG will start the analysis of the BEF-2 data matrix around April 2023, involving also the ECHA Biocides Unit in retrieving supplementing information from R4BP 3 database (or ECHA dissemination website) such as: i) product type; ii) user category; iii) active substance names; iv) CAS numbers; v) authorisation start and end date. The preliminary results of the BEF-2 are expected at the BPRS-19.

The BPRS Training event was remotely delivered on 2 December 2022. The training was focused on 'CLP for biocides, in situ generation systems, and BPR borderline issues'. More than 400 participants attended the event. Almost all participants rated the training as 'excellent' or 'good'.

BPRS finalised Practical Issues on legal aspects of 'ecolabelling' for biocidal products (i.e. issue BPRS-17.1) and authorised rodenticides sold to non-professional users (i.e. issue BPRS-16.1). Two new practical issues are currently under discussion with the BPRS members touching upon labelling obligations for biocides (i.e. issue BPRS-18.1) and concentrations of biocidal products (i.e. issue BPRS-18.2).

Item 19 - A.O.B.

19.1 Forum Chairs election in June 2023

The elections of Forum Chairs will take place in June, during the physical meeting Forum-44. Forum members were invited to consider the possibility to take up the role of Forum Chair or Vice-chair and submit nominations to HET by 26 May. The candidates will be invited to attend the pre-meeting of Forum-44.

19.2 Enforcement of authorisation conditions of 1,2-Dichloroethane

The German Forum member shared the experiences encountered by a German NEA when trying to enforce authorisation conditions (specifically the monitoring requirements) for the substance 1,2-Dichloroethane. Forum members were invited to share their experiences on enforcing monitoring conditions required in authorisation decisions.

19.3 Derogations from entries 28-30 of Annex XVII for artists paints

Forum members were invited to indicate their experience with interpreting the scope of derogation for artists paints (what products are covered). It was suggested for the presenter to submit it as a practical issue for discussion with the Forum at one of the future meetings.
