## Extension of expiry date for national authorisation of the biocidal product Mosquito Milk Spray 9,5% DEET

The biocidal product Mosquito Milk Spray 9,5% DEET is authorised in Iceland under the asset number IS-0024139-0000. The expiry date of the authorisation is 1 November 2023. The authorisation holder, Jaico RDP nv, submitted an application for renewal of national authorisation on 29 April 2022, case No BC-FT075268-12.

The biocidal product contains the active substance N,N-diethyl-meta-toluamide (CAS No 134-62-3). The expiry date of the approval of N,N-diethyl-meta-toluamide for use in biocidal products of product-type 19 is 31 Januar 2025 and a renewal of the approval is in process.

Member states are allowed to extend the duration of their current authorisation where, for reasons beyond the control of the authorisation holder, no decision is taken on the renewal of the authorisation before its expiry, in accordance with Article 31(7) of Regulation (EU) No 528/2012 and Article 5(4) of Commission Delegated Regulation (EU) No 492/2014.

The renewal process of the active substance N,N-diethyl-meta-toluamide is ongoing and it is foreseen that a decision on the renewal will not be made before the expiry date of the biocidal product. Belgium, as the reference Member State for the renewal, has extended the authorisation for Mosquito Milk Spray 9,5% DEET until 12 January 2025. Authorisations that are granted by a concerned Member State should have the same expiry date that the authorisation which is mutually recognised, as agreed on CA level (CA-Sept14-Doc.5.7-Final). Therefore, it is appropriate to also extend the expiry date of the product authorisation in Iceland.

The expiry date of the product authorisation for Mosquito Milk Spray 9,5% DEET, UST202005-046, is hereby extended until **12 January 2025**.

Apart from the extension of the expiry date outlined above, the authorisation conditions as stated in the authorisation letter dated 2 July 2020 with later amendments remain valid.



This administrative decision may be appealed to the Minister for the Environment, Energy and Climate, in accordance with Article 68 of the Chemicals Act No 61/2013 and Article 26 of the Icelandic Administrative Act No 37/1993. Appeals should be directed, within three months from the receival of this decision, to the Ministry of Environment, Energy and Climate, Skuggasundi 1, 101 Reykjavík, Iceland.
