NEU 1193 I is a ready to use fly bait decal for windows against flies. It is intended for indoor use in houses including living and sleeping rooms by non-professional users.

Detailed description:
For the control of flies NEU 1193 I fly bait decal for windows based on the active substance spinosad are stuck on upper third of the window.

Application rate(s) and frequencies

Application Rate: Max. 1 fly bait decals per window.
Dilution (%): 100
Number and timing of application:
NEU 1193 I contains 36 g spinosad (pure active content)/kg of the product (that is applied on the fly bait decals). The fly bait decals have a size of 20 cm² with 0.063 mg spinosad/cm². The fly bait decals are to be directly attached to the upper third of the window as ready to use. It is expected that a maximum of 1 sticker used per window provide sufficient efficacy for 6 weeks. This corresponds to a total application rate of 1 sticker per window and an interval of 4 - 6 weeks (equivalent to 0.00127 g spinosad/per window).

5. General directions for use

5.1. Instructions for use

Use fly bait decals per window (in house including living and sleeping rooms) applied on upper third of the window, the decals are to be replaced after 6 weeks if necessary. Apply a maximum of one package per day.

5.2. Risk mitigation measures

- Keep out of reach of children.
- Avoid contact with eyes.
- Store in the package and within the inner plastic bag
- Avoid cleaning of the stickers. If this occurs, immediately dispose cleaning cloth to domestic waste.

5.3. Particulars of likely direct or indirect effects, first aid instructions and emergency measures to protect the environment

First aid measures:

- IF IN EYES: Rinse cautiously with water for several minutes.Remove contact lenses, if present and easy to do. Continue rinsing. Immediately call a doctor.
 - Ensure of fresh air.
 - In case of contact with skin wash off with soap and water.
 - In the event of persistent symptoms seek medical treatment.
 - In case of ingestion consult a physician if symptoms appear.
- No specific antidote known. Treatment: symptomatically.

Accidental release measures:

- Use personal protective clothing.
- Do not discharge into the drains or bodies of water.
- Glue contamination can be removed with usual cleaners.

Dispose of fly bait decals to hazardous waste. The cardboard packaging should be handled according to municipal waste regulations.

5.5. Conditions of storage and shelf-life of the product under normal conditions of storage

Do not store together with animal feedstuffs.
