On an authorisation of the biocidal product family Wolmanit CX-8WB_family

Latvian Environment, Geology and Meteorology Centre (LEGMC) has evaluated an application submitted by **Wolman Wood and Fire Protection GmbH** on 9 July 2021 concerning an authorisation of **Wolmanit CX-8WB_family** through mutual recognition in sequence.

LEGMC has agreed with Product Assessment Report and Summary of Product Characteristics for **Wolmanit CX-8WB_family** developed by the reference Member States – Austria.

Therefore, in accordance with Article 33 of *Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products* (Regulation (EU) No 528/2012), LEGMC authorises the **Wolmanit CX-8WB_family** on the basis of mutual recognition process.

The authorisation holder for **Wolmanit CX-8WB_family** in Latvia is:

Wolman Wood and Fire Protection GmbH.

Wolmanit CX-8WB_family contains following active substances:

- **Basic Copper carbonate** (CAS No 12069-69-1, EC No 235-113-6) at the concentration range **13,04 – 13,04%**.
- **Cu-HDO** (CAS No 312600-89-8) at the concentration range **2,8 – 2,8%**.

LEGMC assigns the authorisation number for Wolmanit CX-8WB_family:

LV/2021/MR/022.

The authorisation for Wolmanit CX-8WB_family is valid until 29 March 2031 based on reference Member State decision.

In accordance with Article 22(2)(d) of the Regulation (EU) 528/2012 authorisation numbers with the following suffix for biocidal products within family are indicated in the following table:

The authorisation number shall be indicated on the label of the biocidal product.

The authorisation of **Wolmanit CX-8WB_family** through mutual recognition is granted on the following terms:

- Product type: 8 – Wood preservatives;
- Target organism: wood destroying fungi (brown rot fungi; white rot fungi; soft rot fungi); wood boring beetles; termites (subterranean termites): *Reticulitermes spp*;
- Users: industrial;
- Product description: soluble concentrate;
- Product stability: up to 24 months;
- Field of use – indoor;
- Pack sizes and packaging material: as indicated in Summary of Product Characteristics.

The authorisation through mutual recognition applies only to **Wolmanit CX-8WB_family** in the composition, form and packing for which the first authorisation for **Wolmanit CX-8WB_family** is granted by reference Member State.

The information on the label (and if applicable an enclosed instruction of use) of the **Wolmanit CX-8WB_family** should be as it is indicated in the first authorisation of above-mentioned product, taking into account also the information which is stated in the Product Assessment Report and Summary of Product Characteristics issued by reference Member State.

The information on the label shall be in Latvian.

Notwithstanding content of the label specified above, requirements stated in:

- *Article 69 Regulation (EU) No 528/2012;*
- *Regulation (EC) No. 1272/2008 of the European Parliament and of the Council of 16 December 2008 on classification, labelling and packaging of the substances and mixtures, amending and repealing Directives 67/548/EEC and 1999/45/EC, and amending Regulation (EC) No 1907/2006;*
- all other relevant legislation shall be applied.

Wolman Wood and Fire Protection GmbH shall inform LEGMC about any changes in accordance with *Commission Implementing Regulation (EU) No 354/2013 of 18th April 2013 on changes of biocidal products authorised in accordance with Regulation (EU) No 528/2012 of the European Parliament and of the Council.*

If the first authorisation issued by reference Member State is amended or revoked, the authorisation of **Wolmanit CX-8WB_family** through mutual recognition may be re-opened for review before 29 March 2031.

Application on renewal of an authorisation shall be submitted according to *Commission Delegated Regulation (EU) No 492/2014 of 7 March 2014 supplementing Regulation (EU) No 528/2012 of the European Parliament and of the Council as regards the rules for the renewal of authorisations of biocidal products subject to mutual recognition.*

Additionally, LEGMC would like to inform that Wolman Wood and Fire Protection GmbH is fully responsible of the content of **Wolmanit CX-8WB_family** as well as its classification, labelling, instruction of use and safety data sheet.

LEGMC would like to ask Wolman Wood and Fire Protection GmbH to notify the above-mentioned information down to supply chain.
