## On an authorisation of the biocidal product SPECIAL ONE

Latvian Environment, Geology and Meteorology Centre (LEGMC) has evaluated an application submitted by **Activa s.r.l.** on 25 June 2018 concerning an authorisation of **SPECIAL ONE** through mutual recognition in parallel.

LEGMC has agreed with Product Assessment Report and Summary of Product Characteristics for **SPECIAL ONE** developed by the reference Member States – Greece.

Therefore, in accordance with Article 34 of Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products (Regulation (EU) No 528/2012), LEGMC authorises the SPECIAL ONE on the basis of mutual recognition process.

The authorisation holder for **SPECIAL ONE** in Latvia is:

Activa s.r.l.

Additional trade names for SPECIAL ONE:

- GLADIO;
- VESPA ONE.

The biocidal product **SPECIAL ONE** contains following active substances:

- cyfluthrin (CAS No 68359-37-5, EC No 269-855-7), concentration 0.026%;
- transfluthrin (CAS No 118712-89-3, EC No 405-060-5), concentration 0.114%;
- *piperonyl butoxide* (CAS No 51-03-6, EC No 200-076-7), concentration **0.213%**.

## LEGMC assigns the authorisation number for biocidal product SPECIAL ONE:

## LV/2021/MR/013

The authorisation is valid until 29 July 2031.

The authorisation number shall be indicated on the label of the biocidal product.

The authorisation of **SPECIAL ONE** through mutual recognition is granted on the following terms:

- Product type: 18 Insecticides, acaricides and products to control other arthropods;
- Target organism: German wasps nymphs and adults Vespula germanica; Paper wasp
  larvae and adults Polistes sp.; Oriental cockroach adults Blatta orientalis;



German cockroach – adults – *Blattella germanica*; Black Garden ant – adults – *Lasius niger*;

- Users: general public (non-professional);
- Product description: ready to use aerosol;
- Product stability: 4 years;
- Field of use indoor;
- Pack sizes and packaging material: as indicated in Summary of Product Characteristics.

The authorisation through mutual recognition applies only to the product **SPECIAL ONE** in the composition, form and packing for which the first authorisation is granted by reference Member State to **SPECIAL ONE**.

The information on the label (and if applicable an enclosed instruction of use) of the **SPECIAL ONE** should be as it is indicated in the first authorisation of above-mentioned product, taking into account also the information which is stated in the Product Assessment Report and Summary of Product Characteristics issued by reference Member State.

The information on the label shall be in Latvian.

Notwithstanding content of the label specified above, requirements stated in:

- Article 69 Regulation (EU) No 528/2012;
- Regulation (EC) No 1272/2008 of the European Parliament and of the Council of 16 December 2008 on classification, labelling and packaging of the substances and mixtures, amending and repealing Directives 67/548/EEC and 1999/45/EC, and amending Regulation (EC) No 1907/2006;
- all other relevant legislation shall be applied.

Activa s.r.l. shall inform LEGMC about any changes in accordance with Commission Implementing Regulation (EU) No 354/2013 of 18<sup>th</sup> April 2013 on changes of biocidal products authorised in accordance with Regulation (EU) No 528/2012 of the European Parliament and of the Council.

If the first authorisation issued by reference Member State is amended or revoked, the authorisation of **SPECIAL ONE** through mutual recognition may be re-opened for review before 29 July 2031.

Application on renewal of an authorisation shall be submitted according to Commission Delegated Regulation (EU) No 492/2014 of 7 March 2014 supplementing Regulation (EU) No 528/2012 of the European Parliament and of the Council as regards the rules for the renewal of authorisations of biocidal products subject to mutual recognition.

Additionally, LEGMC would like to inform that Activa s.r.l. is fully responsible of the content of the biocidal product **SPECIAL ONE** as well as its classification, labelling, instruction of use and safety data sheet.

LEGMC would like to ask Activa s.r.l. to notify the above-mentioned information down to supply chain.
