On authorisation of the biocidal product Wolsit KD-10

Latvian Environment, Geology and Meteorology Centre (LEGMC) has evaluated an application submitted by **Wolman Wood and Fire Protection GmbH** on 18 February 2022 concerning the authorisation of **Wolsit KD-10** through mutual recognition in sequence.

LEGMC has agreed with Product Assessment Report and Summary of Product Characteristics for **Wolsit KD-10** developed by the reference Member States – Finland.

Therefore, in accordance with Article 33 of Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products (Regulation (EU) No 528/2012), LEGMC authorises the **Wolsit KD-10** on the basis of mutual recognition process.

The authorisation holder for Wolsit KD-10 in Latvia is:

Wolman Wood and Fire Protection GmbH.

Additional trade name for Wolsit KD-10:

- Wolsin FC-5.

Wolsit KD-10 contains active substance 1-[[2-(2,4-dichlorophenyl)-4-propyl-1,3-dioxolan-2-yl]methyl]-1H-1,2,4-triazole (Propiconazole) (CAS No. 60207-90-1, EC No. 262-104-4), concentration 4,74%.

LEGMC assigns the authorisation number for Wolsit KD-10:

LV/2022/MR/006.

The authorisation is valid until 28 July 2025.

The authorisation number shall be indicated on the label of the biocidal product.

The authorisation of Wolsit KD-10 through mutual recognition is granted on the following terms:

- Product type: 8 Wood preservatives;
- Target organism: wood rotting fungi; wood disfiguring fungi;
- Users: industrial;

- Product description: soluble concentrate;
- Product stability: 24 months;
- Field of use indoor, outdoor;
- Pack sizes and packaging material: as indicated in Summary of Product Characteristics.

The authorisation through mutual recognition applies only to **Wolsit KD-10** in the composition, form and packing for which the authorisation for **Wolsit KD-10** is granted by reference Member State.

The information on the label (and if applicable an enclosed instruction of use) of the **Wolsit KD-10** should be as it is indicated in the authorisation of the above-mentioned product, taking into account also the information which is stated in the Product Assessment Report and Summary of Product Characteristics issued by reference Member State.

The information on the label shall be in Latvian.

Notwithstanding content of the label specified above, requirements stated in:

- *Article 69 Regulation (EU) No 528/2012*;
- Regulation (EC) No. 1272/2008 of the European Parliament and of the Council of 16 December 2008 on classification, labelling and packaging of the substances and mixtures, amending and repealing Directives 67/548/EEC and 1999/45/EC, and amending Regulation (EC) No 1907/2006;
- all other relevant legislation shall be applied.

Wolman Wood and Fire Protection GmbH shall inform LEGMC about any changes in accordance with Commission Implementing Regulation (EU) No 354/2013 of 18th April 2013 on changes of biocidal products authorised in accordance with Regulation (EU) No 528/2012 of the European Parliament and of the Council.

If the first authorisation issued by reference Member State is amended or revoked, the authorisation of **Wolsit KD-10** through mutual recognition may be re-opened for review before 28 July 2025.

Application on renewal of an authorisation shall be submitted according to Commission Delegated Regulation (EU) No 492/2014 of 7 March 2014 supplementing Regulation (EU) No 528/2012 of the European Parliament and of the Council as regards the rules for the renewal of authorisations of biocidal products subject to mutual recognition.

Additionally, LEGMC would like to inform that Wolman Wood and Fire Protection GmbH is fully responsible of the content of **Wolsit KD-10** as well as its classification, labelling, instruction of use and safety data sheet.

LEGMC would like to ask Wolman Wood and Fire Protection GmbH to notify the above-mentioned information down to the supply chain.
