### **On an authorisation of Deltamethrin SC 25L GIC through mutual recognition**

Latvian Environment, Geology and Meteorology Centre (LEGMC) is the Competent Authority for implementation of *Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products*. On 11<sup>th</sup> June 2015 LEGMC received the application for the authorisation of **Deltamethrin SC 25L GIC** through mutual recognition in parallel submitted by Bayer S.A.S.

LEGMC has agreed with Product Assessment Report and Summary of Product Characteristics for **Deltamethrin SC 25L GIC** developed by the reference Member State – Poland.

Therefore, in accordance with Article 34 of Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products LEGMC authorise the **Deltamethrin SC 25L GIC** on the basis of mutual recognition process.

The authorisation holder for **Deltamethrin SC 25L GIC** in Latvia is:

**Bayer A/S.**

**Deltamethrin SC 25L GIC** contains 2.49 % (w/w) of *deltamethrin* (CAS No. 52918-63-5, EC No. 258-256-6) as active substance.

**LEGMC assigns the authorisation number of Deltamethrin SC 25L GIC through mutual recognition:**

**LV/2018/MR/016**

Additional trade name for **Deltamethrin SC 25L GIC** in Latvia is:

- *K-Othrine Flexx.*

**The authorisation of Deltamethrin SC 25L GIC through mutual recognition is valid until 15<sup>th</sup> May 2028 based on reference Member State – Poland decision.**

The authorisation number of **Deltamethrin SC 25L GIC** through mutual recognition shall be indicated on the label of the biocidal product.

The authorisation of **Deltamethrin SC 25L GIC** through mutual recognition is granted on the following terms:

- Product type: it is only authorised for use as a product type 18 – Insecticides, acaricides and other products to control arthropods – crawling insects including cockroach (*Blattella germanica* and *Periplaneta americana*), bed bug (*Cimex lectularius*), spiders, house flies (*Musca domestica*) and wasps (*Vespula germanica*);

- Users: professional and trained professional;
- Product description: suspension concentrate insecticide for use against crawling insects including cockroaches, bed bugs, spiders, house flies and wasps;
- Product stability: shelf life 2 years;
- Use area: indoors use in/at private and public areas;
- Packaging size: bottle (HDPE) from 2.5ml up to 5L.

The authorisation through mutual recognition applies only to the biocidal product **Deltamethrin SC 25L GIC** in the composition, form and packing material for which the first authorisation is granted by reference Member State to **K-Othrine Flexx**.

The information on the label (and if applicable an enclosed instruction of use) of the **Deltamethrin SC 25L GIC** should be as it is indicated in the first authorisation of above mentioned biocidal product, taking into account also the information which is stated in the Product Assessment Report and Summary of Product Characteristics issued by reference Member State.

The information on the label shall be in Latvian.

Notwithstanding content of the label specified above, requirements stated in:

- Article 69 of Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products,
- Regulation (EC) No. 1272/2008 of the European Parliament and of the Council of 16 December 2008 on classification, labelling and packaging of the substances and mixtures, amending and repealing Directives 67/548/EEC and 1999/45/EC, and amending Regulation (EC) No 1907/2006,
- all other relevant legislation shall be applied.

Bayer A/S as the authorisation holder shall inform LEGMC about any changes in accordance with Commission Implementing Regulation (EU) No 354/2013 of 18<sup>th</sup> April 2013 on changes of biocidal products authorised in accordance with Regulation (EU) No 528/2012 of the European Parliament and of the Council.


If the first authorisation issued by reference Member State is amended or revoked, the authorisation of **Deltamethrin SC 25L GIC** through mutual recognition may be re-opened for review before the 15<sup>th</sup> May 2028.

Additionally LEGMC would like to inform that Bayer A/SB is fully responsible of the content of the biocidal product **Deltamethrin SC 25L GIC** as well as its classification, labelling, instruction of use and safety data sheet.

LEGMC would like to ask Bayer A/S to notify the above mentioned information down to supply chain.
