5. General directions for use

5.1. Instructions for use

- Apply and spread evenly on the skin zones to protect (arms, hands, legs, feet and face).
- Adults: 102 spray pump a day (24 on arm, 48 on leg, 12 on the face, 5 on hands and 13 on feet)
- Children (6-12 years): 56 spray pump a day (13 on arm, 30 on leg, 6 on the face, 7 on feet)
- Children (2-6 years): 42 spray pump a day (11 on arm, 20 on leg, 6 on the face, 5 on feet)
- Toddlers (1-2 years): 29 spray pump a day (8 on arm, 14 on leg, 4 on the face, 3 on feet) .
- Spray directly on the exposed skin and distribute the liquid with the hand. Do not spray directly on the face. Spray the product on your hands first if you want to protect your face. For the treatment of the face, spray repellent solution on the palm of the hand and distribute the solution on the skin of the face, taking care to protect the eyes. Wash your hands thoroughly after applying the product.
 - Once the time of protection is over (4 hours after application), properly wash the body area where the product has been applied.
 - CHILDREN MUST NOT APPLY THIS PRODUCT. An adult should apply the product on children below 12 years of age. Do not apply on children's hands.
- Do not use in children younger than 1 years. If necessary, should first consult your pediatrician.
- Frequent and repeated application of this product is unnecessary
- The product is not intended to be used in tropical areas.
- The use of the product with other repellent products is not recommended.
- If the product is to be used in combination with suntan lotion, first apply the suntan lotion and wait 30 minutes before applying the product.
- The protection time is only indicative. Environmental factors (e.g. high temperature, wind velocity, exposure to water) can modify it.
- The product is not intended for use on animals / pets

5.2. Risk mitigation measures

- Always read the label and product information before use. Avoid breathing the spray.
- Use only outdoors or in well ventilated areas.
- Do not swallow.
- Avoid breathing vapours/spray.
- Do not use on children's hands.
- For children of 1 to 12 years: the repellent must be applied by adults.
- Keep out of reach of children.
- Do not use near food and surfaces that may come into contact with food and feed or drinks for human consumption and animal feedingstuffs.
- Avoid contact of the treated skin with food and feed.
- Do not use near domestic animals.
- Do not use in people sensitive to its components.
- Keep the container upright.
- In natural water bodies, such as lakes or rivers, do not go swimming after application of the product.

5.3. Particulars of likely direct or indirect effects, first aid instructions and emergency measures to protect the environment

First aid instructions:

IF INHALED : If symptoms occur call a POISON CENTRE or a doctor.

IF SWALLOWED : Rinse mouth. Give something to drink, if exposed person is able to swallow. Do NOT induce vomiting. Call a POISON CENTRE or a doctor

IF ON SKIN : Wash skin with water. If symptoms occur call a POISON CENTRE or a doctor. Only the part of the skin that were not supposed to be exposed should be washed. If irritation occurs the skin should be washed and medical advice should be sought.

IF IN EYES : Rinse with water. Remove contact lenses, if present and easy to do. Continue rinsing for 5 minutes. Call a POISON CENTRE or a doctor.

IF MEDICAL ADVICE IS NEEDED, HAVE THE PRODUCT CONTAINER OR LABEL AT HAND AND CONTACT THE POISON CONTROL CENTER

Environmental precautions:

Keep away from drains, surface and ground water, and soil.

Methods and material for containment and cleaning up: Collect the spilled liquid with non-combustible absorbent materials (i.e. dirt, sand, vermiculite, diatomaceous earth). Pour the product and the absorbent in a suitable container. Contaminated areas should be cleaned immediately with a suitable decontaminant. Add the same decontaminant to the remnants and let stand for several days until no further reaction in an unsealed container

5.4. Instructions for safe disposal of the product and its packaging

Empty containers, unused product and other waste generated during the treatment are considered hazardous waste. Dispose of in accordance with current regulations.

Do not release to soil, ground, surface water or any kind of sewer.

5.5. Conditions of storage and shelf-life of the product under normal conditions of storage

Keep out of reach of children and non-target animals/pets

Observe label precautions.

Store containers between 5 and 35°C in a dry and well-ventilated place away from heat and direct sunlight.

Keep away from sources of ignition.

Keep away from oxidising agents, strong alkalis, strong acids. No smoking. Prevent unauthorised access.

Containers that have been opened must be carefully resealed and kept upright to prevent leakage.
