# ON THE IDENTIFICATION OF POTASSIUM HYDROXYOCTAOXODIZINCATEDICHROMATE

### AS A SUBSTANCE OF VERY HIGH CONCERN

France presented a proposal in accordance with Article 59(3) and Annex XV of the REACH Regulation (25 August 2011, submission number CP004377-37) on identification of the *Potassium hydroxyoctaoxodizincatedichromate*(1-) as a substance of very high concern because of its carcinogenic properties.

The Annex XV dossier was circulated to Member States on 29 August 2011 and the Annex XV report was made available to interested parties on the ECHA website on the same day according to Articles 59(3) and 59(4).

Comments were received by both Member States and interested parties on the proposal.

The dossier was referred to the Member State Committee on 14 November 2011 and agreed in the written procedure of the Member State Committee with closing date of 24 November 2011.

# Agreement of the Member State Committee in accordance with Article 59(8):

Potassium hydroxyoctaoxodizincatedichromate (1-) is identified as a substance meeting the criteria of Article 57 (a) of Regulation (EC) 1907/2006 (REACH) owing to its classification as carcinogen  $1A^2$ . This classification corresponds to classification as carcinogen category  $1^3$ .

# UNDERLYING ARGUMENTATION FOR IDENTIFICATION OF SUBSTANCE OF VERY HIGH CONCERN

## **Carcinogenicity:**

Potassium hydroxyoctaoxodizincatedichromate(1-) is covered by index number 024-007-00-3 'zinc chromates including zinc potassium chromate' of Regulation (EC) No 1272/2008 and classified in Annex VI, part 3, Table 3.1 (the list of harmonised classification and labelling of hazardous substances) as carcinogen, Carc. 1A (H350: "May cause cancer"). The corresponding classification in Annex VI, part 3, Table 3.2 (the list of harmonised classification and labelling of hazardous substances from Annex I to Directive 67/548/EEC) of Regulation (EC) No 1272/2008 is carcinogen, Carc. Cat. 1 (R45: "May cause cancer").

Therefore, this classification of potassium hydroxyoctaoxodizincatedichromate(1-) in Regulation (EC) No 1272/2008 shows that it meets the criteria for classification as carcinogen in accordance with Article 57 (a) of REACH.
