Whereas

- (1) Pursuant to Article 59(3) of Regulation (EC) No 1907/2006 of the European Parliament and of the Council of 18 December 2006 concerning the Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH) the European Chemicals Agency (hereinafter referred to as 'ECHA' or 'The Agency') received from Member States ten dossiers in accordance with Annex XV to REACH for substances which in their opinion meet the criteria of Substances of Very High Concern (SVHCs) set out in Article 57 of REACH.
- (2) On 1 September 2014, the Agency invited all interested parties to submit comments on the Annex XV dossiers, as stated in Article 59(4) REACH.
- (3) The public commenting period for all substances ended on 16 October 2014.
- (4) In accordance with Article 59(5) REACH, the deadline for Member States or the Agency to comment on the identification of the substances as SVHCs was 31 October 2014.
- (5) The Agency received comments on the identification as SVHCs for the following substances:

- (6) Thus, pursuant to Article 59(7) of REACH the dossiers related to these substances were referred to the Member State Committee (MSC).
- (7) The MSC unanimously agreed via written procedure, which closed on 27 November 2014, and at its 39th meeting (8-11 December 2014) that the following substances meet the criteria set out in Article 57 of REACH for identification as SVHCs:

- (8) Therefore, pursuant to Article 59(8) of REACH the Agency shall now include these substances in the Candidate List.
- (9) The MSC also unanimously agreed at its 39^{th} meeting that the following substance meets the criteria set out in Article 57(f) of REACH for identification as SVHC on the basis of an equivalent level of concern having probable serious effects to the environment.

- (10) As the substance bis(2-ethylhexyl) phthalate (DEHP) is already listed on the Candidate List, this entry shall now be updated to reflect the additional reason for inclusion, i.e. that it demonstrates an equivalent level of concern having probable serious effects to the environment in accordance with Article 57(f) of REACH.
- (11) Therefore, pursuant to Article 59(8) of REACH the Agency shall now update the entry for bis(2-ethylhexyl) phthalate (DEHP).
- (12) The Member State Committee at its 39th meeting did not unanimously agree that the following substances meet the criteria set out in Article 57(f) of REACH, i.e. that they demonstrate an equivalent level of concern having probable serious effects to human health:

- (13) The entries for these substances in the Candidate List shall therefore not be updated on this ground.
- (14) In accordance with Article 59(10) REACH, the Candidate List shall be published on ECHA's website.
