# Acceptance of administrative change to the authorisation for Hygienix B.V. – Hygienix Light Duty Cleaning and Disinfection Liquid LDL-L-0616008 (wipes) – EU-0018737-0000

With reference to the notification dated 23 May 2024 for administrative changes to the authorisation of the biocidal product Hygienix Light Duty Cleaning and Disinfection Liquid LDL-L-0616008 (wipes), R4BP 3 case number BC-AC095159-48.

## Decision

The Norwegian Environment Agency hereby accepts the notified administrative changes to the product authorisation for Hygienix Light Duty Cleaning and Disinfection Liquid LDL-L-0616008 (wipes) on the Norwegian market.

### Terms and conditions for the change to the authorisation

The revised terms and conditions are described in the final Norwegian Summary of Product Characteristic (SPC) attached to the R4BP3 asset no. NO-0027932-0000. The final SPC can also be found on the website of the European Chemicals Agency here: <a href="Information on biocides - ECHA">Information on biocides - ECHA</a> (europa.eu). The terms and conditions as stated in the authorisation letter dated 3 March 2022 also apply.

The electronic copy of the label(s) must be submitted within three months from the date of this letter. Please mark the email with the authorisation number.

The approval is given in accordance with Article 6(4) of Regulation (EU) No 354/2013, c.f. Article 50 of Regulation (EU) No 528/2012 (the Biocidal Products Regulation, BPR).



# Background

Regulation (EU) No. 528/2012 and Regulation (EU) No 354/2013 are implemented in Norwegian law through the Norwegian Biocide Regulation of 18 April 2017 No. 480.

Since this biocidal product is placed on the Norwegian market under Article 27 of the BPR, the changes to the terms and conditions in the simplified product authorisation granted by the Netherlands will also apply to the notification in Norway.

The procedure for applications for administrative notifications to authorisations are set out in Article 6 of Regulation (EU) No 354/2013.

### The notification concerns

Hygienix B.V. has notified administrative change(s) to the authorisation of Hygienix Light Duty Cleaning and Disinfection Liquid LDL-L-0616008 (wipes) on the Norwegian market. The notified changes concerns removal of the following trade names in the notification in Norway, as referred to in Section 1 of Title 1 to the Annex to Regulation (EU) No 354/2013: "Glorix Disinfect & Shine Multipurpose Wipes Original", "Seventh Generation Disinfect & Clear Multipurpose Wipes Original", "Seventh Generation Disinfect & Shine Multipurpose Wipes Original" and "Cif Disinfect & Shine Multipurpose Wipes Original".

# Evaluation by the Norwegian Environment Agency

The Norwegian Environment Agency considers the changes to meet the conditions in Title 1, Section 1 of Annex to Regulation (EU) no 354/2013 and therefore are acceptable.

# Right to appeal

This decision may be appealed to the Ministry of Climate and Environment.

An appeal shall be submitted to the Norwegian Environment Agency within three weeks after receipt of this letter.
