### **On an authorisation of *STORM ultra* through mutual recognition in Latvia**

Latvian Environment, Geology and Meteorology Centre (LEGMC) has evaluated an application submitted by **BASF SIA** on 11<sup>th</sup> May 2016 concerning an authorisation of **STORM ultra** through mutual recognition in parallel.

LEGMC has agreed with Product Assessment Report and Summary of Product Characteristics for **STORM ultra** developed by the reference Member State – Netherlands.

Therefore, in accordance with Article 34 of *Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products* (Regulation (EU) No 528/2012) LEGMC authorises the **STORM ultra** on the basis of mutual recognition process.

The authorisation holder for **STORM ultra** in Latvia is:

**BASF SIA.**

**STORM ultra** contains **0.0025 % (w/w)** of *flocoumafen* (CAS No. 90035-08-8, EC No. 421-960-0) as active substance.

**LEGMC assigns the authorisation number for biocidal product *STORM ultra* through mutual recognition:**

**LV/2019/MR/002**

Additional trade names for **STORM ultra** in Latvia are:

- *STORM Ultra Secure*;
- *STORM Ultra Block Baits (BB)*;
- *VEOR*;
- *SECUVIA*.

**The authorisation of *STORM ultra* through mutual recognition is valid until 7<sup>th</sup> December 2023 based on reference Member State – Netherlands decision.**

The authorisation number of **STORM ultra** through mutual recognition shall be indicated on the label of the biocidal product.

The authorisation of **STORM ultra** through mutual recognition is granted on the following terms:

- Product type: 14 – Rodenticides;
- Target organisms: house mouse – juveniles and adults – *Mus musculus*, brown rat – juveniles and adults – *Rattus norvegicus*, roof rat – juveniles and adults – *Rattus rattus*;

- Users: general public, professional, trained professional;
- Product description: ready to use bait;
- Product stability: shelf life - 2 years;
- Use area: indoor and outdoor areas;
- Packaging size: packaging sizes and materials are indicated in Summary of Product Characteristics.

The authorisation through mutual recognition applies only to the biocidal product **STORM ultra** in the composition, form and packing material for which the first authorisation is granted by reference Member State to the biocidal product **STORM ultra**.

The information on the label (and if applicable an enclosed instruction of use) of the **STORM ultra** should be as it is indicated in the first authorisation of above mentioned biocidal product, taking into account also the information which is stated in the Product Assessment Report and Summary of Product Characteristics issued by reference Member State.

The information on the label shall be in Latvian.

Notwithstanding content of the label specified above, requirements stated in:

- Article 69 of *Regulation (EU) No 528/2012*,
- *Regulation (EC) No. 1272/2008 of the European Parliament and of the Council of 16 December 2008 on classification, labelling and packaging of the substances and mixtures, amending and repealing Directives 67/548/EEC and 1999/45/EC, and amending Regulation (EC) No 1907/2006*,
- all other relevant legislation shall be applied.

BASF SIA as the authorisation holder shall inform LEGMC about any changes in accordance with *Commission Implementing Regulation (EU) No 354/2013 of 18<sup>th</sup> April 2013 on changes of biocidal products authorised in accordance with Regulation (EU) No 528/2012 of the European Parliament and of the Council*.

If the first authorisation issued by reference Member State is amended or revoked, the authorisation of the biocidal product **STORM ultra** through mutual recognition may be re-opened for review before the 7<sup>th</sup> December 2023.

Additionally LEGMC would like to inform that BASF SIA is fully responsible of the content of the biocidal product **STORM ultra** as well as its classification, labelling, instruction of use and safety data sheet.

LEGMC would like to ask BASF SIA to notify the above mentioned information down to supply chain.
