On an authorisation of the biocidal product ENCLEAN RTU

Latvian Environment, Geology and Meteorology Centre (LEGMC) has evaluated an application submitted by **Belchim Crop Protection NV** on 2nd April 2019 concerning an authorisation of **ENCLEAN RTU** through mutual recognition in sequence.

LEGMC has agreed with Product Assessment Report and Summary of Product Characteristics developed by the reference Member States – France.

Therefore, in accordance with Article 33 of Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products (Regulation (EU) No 528/2012), LEGMC authorises ENCLEAN RTU on the basis of mutual recognition process.

ENCLEAN RTU contains 2.24% of *nonanoic acid* (CAS No. 112-05-0, EC No. 203-931-2) as active substance.

LEGMC assigns the authorisation number LV/2020/MR/010.

The authorisation number shall be indicated on the label of the biocidal product.

The authorisation is valid until 14th October 2028.

The authorisation holder is **Belchim Crop Protection NV**.

The authorisation is granted on the following terms:

- Product type: 2 Disinfectants and algaecides not intended for direct application to humans or animals (Disinfectants);
- Target organism: green algae;
- Users: professional and non-professional;
- Product description: liquid;
- Product stability: 24 months;
- Field of use outdoor use, spraying;
- Pack sizes and packaging material: as indicated in Summary of Product Characteristics.

The authorisation through mutual recognition applies only to the product ENCLEAN RTU in the composition, form and packing for which the first authorisation is granted by reference Member State.



The information on the label (and if applicable an enclosed instruction of use) should be as it is indicated in the first authorisation of the above mentioned product, taking into account also the information which is stated in the Product Assessment Report and Summary of Product Characteristics issued by reference Member State.

The information on the label shall be in Latvian.

Notwithstanding content of the label specified above, requirements stated in:

- Article 69 Regulation (EU) No 528/2012;
- Regulation (EC) No 1272/2008 of the European Parliament and of the Council of 16 December 2008 on classification, labelling and packaging of the substances and mixtures, amending and repealing Directives 67/548/EEC and 1999/45/EC, and amending Regulation (EC) No 1907/2006;
- all other relevant legislation shall be applied.

Belchim Crop Protection NV shall inform LEGMC about any changes in accordance with Commission Implementing Regulation (EU) No 354/2013 of 18th April 2013 on changes of biocidal products authorised in accordance with Regulation (EU) No 528/2012 of the European Parliament and of the Council.

If the first authorisation issued by reference Member State is amended or revoked, the authorisation of ENCLEAN RTU through mutual recognition may be re-opened for review before 14th October 2028.

Application on renewal of an authorisation shall be submitted according to Commission Delegated Regulation (EU) No 492/2014 of 7 March 2014 supplementing Regulation (EU) No 528/2012 of the European Parliament and of the Council as regards the rules for the renewal of authorisations of biocidal products subject to mutual recognition.

Additionally, LEGMC would like to inform that Belchim Crop Protection NV is fully responsible of the content of the biocidal product ENCLEAN RTU as well as its classification, labelling, instruction of use and safety data sheet.

LEGMC would like to ask Belchim Crop Protection NV to notify the above mentioned information down to supply chain.
