On the renewal of authorisation for BRODITEC G-29

Latvian Environment, Geology and Meteorology Centre (LEGMC) received an application submitted by Zapi S.p.A. on the 24th July 2017 for renewal of national authorisation in accordance with Article 31(1) of Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products for BRODITEC G-29 (authorisation number: LV/2017/MR/013) through Biocidal Product Register (Asset No. LV-0017193-0000).

LEGMC has agreed with Product Assessment Report and Summary of Product Characteristics for **BRODITEC G-29** developed by the reference Member States – United Kingdom.

Therefore, in accordance with Article 5 of the Commission Delegated Regulation (EU) No 492/2014 of 7 March 2014 supplementing Regulation (EU) No 528/2012 of the European Parliament and of the Council as regards the rules for renewal of authorisation of biocidal products subject to mutual recognition the authorisation for BRODITEC G-29 is renewed and is valid until 15 February 2023.

BRODITEC G-29 contains 0.0029% of brodifacoum (CAS No. 56073-10-0; EC No. 259-980-5) and is renewed on the following terms:

- Product type: it is only authorised for use as a product type 14 Rodenticide house mice (Mus musculus) and brown rats (Rattus norvegicus);
- Users: trained professional, professional and non-professional;
- Product description: for non-professional ready-to-use bait to be used in tamperresistant bait stations, for professional - ready-to-use bait to be used in tamper-resistant bait stations and for trained professional - ready-to-use bait to be used in tamper-resistant bait stations, covered and protected baiting points;
- Product stability: shelf life 2 years;
- Use area: indoors, outdoors around buildings;
