On a notification for placing on the Latvian market of the biocidal product FLY IN

Latvian Environment, Geology and Meteorology Centre (LEGMC) on 2nd March 2022 received a notification for placing on the market of the biocidal product **FLY IN** in accordance with Article 27 of the Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products (Regulation (EU) 528/2012) submitted by **S.R. Last Shield Limited** through Register for Biocidal Products.

The authorisation under the simplified procedure according Article 25 of the Regulation (EU) 528/2012 for biocidal product **FLY IN** is granted in Italy on the following terms:

- Product type 19 repellents and attractants;
- Trade name: FLY IN;
- Users: professional, general public (non-professional);
- Product description: attractant for flies;
- Target organisms: flies, adults House fly (*Musca domestica*), Stable fly (*Stomoxys calcitrans*);
- Packaging: in accordance with the Summary of Product Characteristics;
- Product stability: 2 years.

FLY IN contains 50% w/w Saccharomyces cerevisiae (yeast) (CAS No. 68876-77-7) and 30% w/w powdered egg as active substances.

LEGMC has agreed with Product Assessment Report and Summary of Product Characteristics for **FLY IN** developed by the reference Member State.

Therefore, in accordance with Article 27 of Regulation (EU) No 528/2012, LEGMC accepts the notification for placing on the Latvian market of the **FLY IN**.

LEGMC assigns an authorisation number IT/2021/00770/AUT. The authorisation number is valid until 12th November 2031 and shall be indicated on the label.

The information on the label (and if applicable an enclosed instruction of use) of the **FLY IN** should be as it is indicated in the authorisation of above mentioned product, taking into account also the information which is stated in the Product Assessment Report and Summary of Product Characteristics issued by reference Member State. The information on the label shall be in Latvian.



Notwithstanding content of the label specified above, requirements stated in:

- Article 69 Regulation (EU) No 528/2012 of the European Parliament and of the Council
 of 22 May 2012 concerning the making available on the market and use of biocidal
 products;
- Regulation (EC) No. 1272/2008 of the European Parliament and of the Council of 16 December 2008 on classification, labelling and packaging of the substances and mixtures, amending and repealing Directives 67/548/EEC and 1999/45/EC, and amending Regulation (EC) No 1907/2006, shall be applied.

Additionally LEGMC would like to inform that **S.R. Last Shield Limited** is fully responsible of the content of the biocidal product, as well as its labelling, instruction of use and safety data sheet.

If the authorisation issued by reference Member State is amended or revoked, **S.R. Last Shield Limited** shall inform LEGMC on the made changes.
