On authorisation of the biocidal product Ratzia Köder BC through mutual recognition in Latvia

Latvian Environment, Geology and Meteorology Centre (LEGMC) has evaluated an application submitted by Detia Freyberg GmbH on 10th January 2019 concerning an authorisation of the biocidal product *Ratzia Köder BC* through mutual recognition in Latvia.

LEGMC has agreed with Product Assessment Report and Summary of Product Characteristics for *Ratzia Köder BC* developed by the reference Member State – Germany.

Therefore, in accordance with Article 33 of Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products (regulation 528/2012), LEGMC authorises the biocidal product Ratzia Köder BC.

Ratzia Köder BC contains 0.005% of brodifacoum (CAS No.56073-10-0, EC No.259-980-5).

LEGMC assigns the authorisation number LV/2019/MR/004 for Ratzia Köder BC.

The authorisation number is valid until 28th February 2023.

The authorisation number shall be indicated on the label of the biocidal product.

The authorisation of the Ratzia Köder BC is granted on the following terms:

- Product type: 14 rodenticides;
- Target organisms: brown rat and house mice;
- · Fields of use: indoor and outdoor around the buildings;
- Users: professionals;
- Product description: ready to use bait granular bait;
- Pack sizes and packaging material: according to summary of product characteristics;
- Product stability: up to 24 months.

The authorisation applies only to the *Ratzia Köder BC* in the composition, form and packing for which the authorisation is granted by reference Member State.

The information on the label (and if applicable an enclosed instruction of use) of the *Ratzia Köder BC P* shall be as it is indicated in the authorisation of above mentioned product, taking

into account also the information which is stated in the Product Assessment Report and Summary of Product Characteristics issued by reference Member State.

The information on the label shall be in Latvian.

Notwithstanding content of the label specified above, requirements stated in:

- Article 69 Regulation (EU) No 528/2012 of the European Parliament and of the Council
 of 22 May 2012 concerning the making available on the market and use of biocidal
 products;
- Regulation (EC) No. 1272/2008 of the European Parliament and of the Council of 16
 December 2008 on classification, labelling and packaging of the substances and
 mixtures, amending and repealing Directives 67/548/EEC and 1999/45/EC, and
 amending Regulation (EC) No 1907/2006;
- all other relevant legislation shall be applied.

Detia Freyberg GmbH shall inform LEGMC about any changes in accordance with Commission Implementing Regulation (EU) No 354/2013 of 18th April 2013 on changes of biocidal products authorised in accordance with Regulation (EU) No 528/2012 of the European Parliament and of the Council.

If the authorisation issued by reference Member State is amended or revoked, the authorisation of *Ratzia Köder BC* may be re-opened for review before 28th February 2023.

Additionally LEGMC would like to inform that Detia Freyberg GmbH is fully responsible of the content of the biocidal product *Ratzia Köder BC*, as well as its classification, labelling, instruction of use and safety data sheet.

LEGMC would like to ask Detia Freyberg GmbH to notify the above mentioned information down to supply chain.
